

Dear Mr. Weiss:

In response to the Governor's Executive Order 10-14, effective November 1, 2010, the Department of Community Correction respectfully submits that paragraph 5, B – Public Health, Safety, and Welfare applies to the vehicles and positions listed below. The positions are on call 24 hours a day – seven days a week and are on the agency's emergency response team. This team is required to respond immediately to emergencies, agency related or statewide, as stated in the Emergency Disaster Plan. As employees of a law enforcement agency, each of their vehicles is equipped with a police radio that is assigned to them by a specific call number. Therefore in the event of an emergency these positions are able to maintain constant contact with other state law enforcement personnel. The Deputy Director of Field Services, the Assistant Directors and the Internal Affairs positions are also certified law enforcement officers and regularly carry a firearm.

The agency is requesting an exemption from paragraph 4 – requirements to display side decals and display red State license tags. The need for anonymity when in the communities where offenders are supervised is needed when responding to emergencies or engaging in surveillance.

Both supervisors and officers are on call 24 hours a day seven days a week and are required to respond to all emergencies.

The Department of Community Correction respectfully submits that paragraph 5, B – Public Health, Safety, and Welfare, applies to the vehicles and positions listed below. The Probation/Parole Supervisors are certified law enforcement officers who are required to travel extensively to the statewide Probation/Parole Offices to monitor all aspects of their operations. Probation/Parole Officers are required to make home and community contact with their clients. As certified law enforcement officers, Probation/Parole personnel are frequently required to search for violators for apprehension purposes and are often required to transport offenders to detention facilities. Both supervisors and officers are on call 24 hours a day seven days a week and are required to respond to all emergencies.

The agency is requesting exemption from paragraph 4 – requirements to display side decals and display red State license tags. The need for anonymity when in the field

performing investigative operations is essential for security and safety of employees. Anonymity is also consistent with effective supervision of offenders in that it lends itself to the evidence based practice of "place based" supervision.


