OVERVIEW AND PRIORITIES

The creation of the Arkansas Department of Higher Education (ADHE), and its predecessor, the Commission on the Coordination of Higher Education Finance, was predicated on the State's need for financial analysis, coordination, and strategic planning for the provision of public higher education in Arkansas. The scope of the responsibilities has broadened over the years to include determining the roles and scope (mission) of each public institution, approving new academic programs, reviewing existing programs for quality and productivity, and analyzing and reporting all types of institutional and student data. Information is the key commodity used by ADHE to serve the needs of its constituencies—the Governor, the Legislature, and the people of Arkansas. This information includes data on the financial operations of the colleges and universities, statistics about the students who enroll and how they are progressing at these institutions, and information used to provide financial aid to over 20,000 Arkansas college students.

ADHE acquires, generates, analyzes, and monitors data on students, faculty, and institutions to meet these monitoring and service obligations. Over the years, the Governor and the Legislature have given the Department increased responsibility to monitor and report on the academic and fiscal operations of public colleges and universities. This has included gubernatorial and legislative mandates to establish a statewide higher education information system with individual data on every enrolled student and all faculty.

The following define the Department's priorities for the 2003-05 biennium. Each is designed to either restore or maintain capabilities of the agency to meet continuing mandates of the Governor and the Legislature for effective coordination of Arkansas higher education.

- I. Agency Operations/Provision of Basic Services to Governor, Legislature, and Higher Education Institutions
- A. Position Upgrade: The Department requests the upgrade of positions titled Higher Ed Assistant Coordinator of Student Financial Aid Position. These positions are responsible for processing at least 40,000 applications a year that entails verifying individual academic and financial records and determining eligibility of all applicants. It also involves interaction with parents, students, legislators, and the general public in oral and written form to address eligibility or non-eligibility of students, program rules, and program changes. It requires the ability to prepare and interpret statistical reports and analyses for internal and external parties accompanied by recommended program changes; determine scholarship recipient status changes in the form of deferments, transfers to other colleges, and determine students' loan repayment status; and prepare reports for colleges and universities, order funds, and balance the scholarship account for students and institutions. Approximately \$50 million in state government funds are administered by this position. The additional cost for the upgrade of these three incumbents, including fringe benefits will be \$9,207 for the first year and \$9,456 for the second year of the biennium.

- B. Operating Expenses: The Arkansas Department of Higher Education is requesting an increase of \$19,500 for each year of the biennium. Due to the change in the capitalization threshold to \$2,500, the planned workstation rotation of computers will now be expensed from operating funds. Request: Appropriation and Funding An increase of \$19,500 for each year of the biennium.
- C. Capital Outlay: The agency requests \$10,000 in appropriation only, for each year of the biennium. This appropriation would only be used if technology-related equipment unexpectedly has to be replaced and the replacement cost exceeds the limit established for capital/operating (\$2,500).
- D. SREB Dues: The Arkansas Department of Higher Education is requesting an increase of \$73,620 above base level for total SREB dues of \$174,120 in the first year of the biennium and an increase of \$6,000 to \$180,120 in the second year of the biennium. These annual dues pay for the state's participation in the Southern Regional Education Board. In the 1997 Legislative Session, the Department's budget was reduced by 40% even though our fixed costs as well as the SREB dues continued to increase. Subsequently, these dues have been paid from the Department's maintenance and operations funding. The last budget cuts have exhausted our ability to fund these dues from maintenance and operations. Request: Appropriation and Funding An increase of \$73,620 in 2003-2004 and \$79,620 in 2004-2005.

II. Financial Aid Programs to Students

Based on 2000 U.S. Census data, Arkansas is 48th in the U.S. in the number of college graduates per capita and 47th in per capita income. These two are inextricably linked -- higher education attainment is highly correlated with economic development at the state, county, and individual levels. A major factor in Arkansas' low standing is low retention and low graduation rates. Arkansas can greatly benefit from an increased investment in human capital. The payoff will be immediate through continued increases in earning capacity, taxes paid, and workforce productivity. There will also be medium- and long-term improvements in the health of Arkansas, attractiveness to industry, reduced crime, and improved quality of life.

A. Governor's Scholars

The 1997 Arkansas Legislature created the Governor's Distinguished Scholars program as a component of the Governor's Scholars Program. Any applicant who scores a minimum 32 composite ACT scored or a minimum 1410 combined SAT scored, with a 3.50 high school academic GPA OR is named a National Merit Finalist or National Achievement Finalist can receive the Governor's Distinguished scholarship. Instead of an annual award of \$4,000 per year, as was the case with the original Governor's Scholars program, recipients of the Distinguished Scholarship earn full tuition, mandatory fees, room, and board at any Arkansas higher education institution, up to \$10,000 per year. When the award was created, the Arkansas Independent College Association, along with the ADHE, gathered data from ACT and the College Board to estimate how many Arkansas students might qualify. In 1997, it appeared that approximately 150 students in the state met the

qualifications to be named Governor's Distinguished Scholars. ADHE felt conservative in using this number for budget purposes because it was understood that some of the qualifying students would still choose to go out of state, regardless of the generous scholarship offer. The first year of the program, 125 students were awarded the Governor's Distinguished Scholarship.

Since 1997, the number of qualified high school students has increased by over 100%. The primary reason for this sharp increase is that students who had made 30 or 31 ACT score began taking the ACT multiple times to earn a 32 to become eligible for the Governor's Distinguished Scholarship. In addition, many high schools have added Advanced Placement courses to their curriculum, which is a factor in students' preparation for the ACT and SAT tests.

The 2001 General Assembly enacted new program requirements by capping the scholarship amount at \$10,000 per year per student, (previously the scholarship paid full tuition, fees, room and board). In addition, a cap of 250 awards per year was set as well as adding a 3.5 high school grade point to the selection criteria. The drop-out rate for this program, at 3-5%, is very low and the college graduation rate is 98.9%. This program has been very effective at keeping the best and brightest students in state for their college career. Before the inception of this program, only 35% of the top scholars remained in Arkansas, but since the Governor's Distinguished scholarship has been offered, that rate has increased to 80-85%.

Due to the \$14 million cuts to ADHE scholarship programs in 2001-02, eligible Arkansas high school graduates of 2002 were not offered the scholarship. In 2001-02, the program cost \$9 million; the projected expenditure for 2002-03 is \$7.2 million. Anticipated savings from the Academic Challenge Scholarship program with its new eligibility criteria is projected to have the necessary funding for the Governor's Distinguished Scholarship Program. The current appropriation level of \$4,876,588 is insufficient for the funding of this program.

Request: Appropriation - An increase of \$5,123,412 for each year of the biennium 2003-2005.

B. National Guard Tuition Assistance Program

The Arkansas National Guard is requesting \$1 million for the biennium for the National Guard Tuition Assistance Program (GTAP). This program is used to recruit and retrain qualified soldiers/airmen in the Arkansas National Guard. By joining the National Guard young men and women will stay in the state while they pursue an educational goal that will help them to become better educated and trained citizen soldiers and airmen. The GTAP has served a total of 479 soldiers and airmen (full/part time) during the first year of this biennium. Surrounding states have programs, which pay up to 100% of tuition for their soldiers/airmen.

Higher Education Grants Fund carryforward funds used in the 2001-02 budget are depleted and therefore, not available for the 2003-2005 biennium.

Request: Appropriation and funding - \$500,000 for each year of the biennium 2003-2005.

C. Non-Traditional Grant program

House Bill 2370 of 2001, sponsored by Representative Shane Broadway, created the Arkansas Workforce Improvement Scholarship program. While the bill was not signed into law, ADHE is interested in this bill because it addresses a critical sector of the college student population that is not being served with current financial aid programs. Outside of Academic Challenge and Governor's Scholars calls, over 75% of telephone calls received by ADHE are requests from residents over the age of 24 who are or who desire to be college students but can not afford college due to the lack of available financial aid. Most financial aid is geared toward students coming directly out of high school. These financial aid programs are lowering the remediation rate and improving the college graduation rate. The current scholarship programs should be continued, but it should be noted that these financial aid programs are not serving a third of Arkansas' college population.

ADHE is proposing to revisit Representative Broadway's bill by initiating a proposal that is very similar to House Bill 2370. This proposal would entitle the program, "The Arkansas Workforce Improvement Grant Program" and the grant would target potential college students who are deemed "the working poor." Some of the funds that are currently being used for the Arkansas Student Assistance Grant would fund this grant program. Funds for this program would be allocated to institutions based on the school's previous year student enrollment, aged 24 or older. Based on a \$500,000 annual appropriation, up to 500 students would receive the grant each year.

- Arkansas resident and U.S. citizen or permanent resident alien
- Age 24 or older
- Under-employed
- Students who have not earned a baccalaureate degree
- · Students defined as "the working poor"
- Students with a high school diploma, or who have passed the GED, or passes the "Ability to Benefit" criteria as defined by federal regulations

The Workforce Improvement Grant program will serve as an inducement to better educate and upgrade job skills of the Arkansas work force. Details of the grant proposal are outlined below:

- Enrollment in an Arkansas approved institution
- Scholarship amount up to \$1800 per year
- Pell grant recipients would have these funds applied toward the grant award (e.g. Workforce Improvement Grant Amount = Maximum award up to \$1800 Pell Grant Award)

ADHE has surveyed other states and while there is great interest in the Arkansas initiative, no other state has such a program designed to upgrade the skills of the work force. This program would make Arkansas a national leader in this effort.

Request: Appropriation of \$500,000 for Non-Traditional Grant program each year of the biennium 2003-05.

D. Jr./Sr. Minority Teacher Scholarship

The Minority Teacher Scholars Program (MTSP) is designed to provide scholarships to African-American, Asian-American, Native-American, and Hispanic students who have completed 60 semester credit hours, have either been admitted to an approved program resulting in teacher licensure or successfully passed their PPST examination and will be attending a public or private institution of higher education in Arkansas.

The Minority Masters Fellow Program is designed to provide scholarships to African-American, Asian-American, Native-American, and Hispanic students who were recipients of the minority Teacher's Scholarship, and are either entering a master's program or the fifth year of a five-year teacher licensure program.

In order to more efficiently serve the students in the Jr./Sr. Minority Teacher Scholarship program and in the Minority Masters Fellows program, the Department requests reallocation of appropriation in the amount of \$70,000 FROM the Jr./Sr. Minority Teacher Scholarship program TO the Minority Masters Fellows program.

E. Arkansas Health Education Grants

institutions.

The Arkansas Health Education Grant Program (ARHEG) provides assistance for Arkansas residents attending certain out-ofstate accredited health and medical professional schools for graduate or professional programs that are unavailable in Arkansas. Such assistance is currently available for attendance at any accredited school of dentistry, veterinary medicine, optometry, osteopathic medicine, podiatric medicine or chiropractic medicine. The Arkansas Higher Education Coordinating Board (AHECB) determines the priorities for the applicable programs. Based on these priorities and the availability of funding, AHECB establishes the number of student places (contract slots) for entering students in each professional field in which the State has needs that are not satisfied by its own

Based on the freshman and sophomore classes expected to enter in fall 2002 and a full complement in the entering classes in 2003-04 and 2004-05, ADHE requests an increase in these disciplines in order to continue the slot allocations for entering students established by the AHECB for 1994-95. During the current biennium, carryforward funds have been used to fund some of these slots.

This request will allow ADHE to continue the program at the same level of students served since 94-95.

The marked increases in total program costs for the biennium are due to substantial increases in the Southern Regional Education Board contract fees per student in response to rising tuition and fees at the participating institutions. Contract fees per student for 2003-04 exceed those of 2002-03 by 6-10% and contract fees per student for 2004-05 exceed those of 2003-04 by 1-16% as shown in the chart below:

Request: Funding and Appropriation - An increase of \$398,772 in 2003-04 and an increase of \$732,861 in 2004-05.

III. Cash Appropriation

The Department is requesting additional cash appropriation for operating and conference expenses in the amount of \$15,620 each year of the biennium. This request will provide the Department with appropriation flexibility in the event funds are received from the private sector and to provide the Department with authority to expend cash revenue derived from investments/interest bearing accounts.

IV. Higher Education Building Maintenance Fund

The Department is requesting restoration of the current biennial appropriation amount of \$26,000,000 for the 2003-05 biennium for the maintenance of facilities at the institutions of higher education.

V. Research Development Fund

The Department is requesting restoration of the current biennial appropriation amount of \$10,000,000 for the 2003-05 biennium to provide Arkansas Research and Development Program grants to institutions of higher education in Arkansas.

VI. Workforce Training Consortium

The Workforce Training Consortium is a consortium of all two-year colleges in Arkansas through the Arkansas Association of Two-Year Colleges. The Consortium was established to:

- Help facilitate the development of resources and capacity on the two-year campuses to better serve business and industry through customized workforce training.
- · Provide staff development for the business and industry staff of the two-year colleges.
- Develop a mechanism and facilitate the sharing of staff and training among campuses so that businesses and industries can receive training from their local college but use the knowledge and resources of all 23 campuses.
- · Support programs that allow the sharing of best practices among all institutions.
- Develop a standardized reporting and accountability system.
- Provide direction and information that would inform businesses of services and guide two-year colleges in recognizing business training needs and trends for training.
- · Coordinate business-training projects that require the resources of more than one college.
- . Coordinate Cisco Academy training and the efforts of the 9 Regional Cisco Academies and 80 Local academies.
- · Develop state-of-the-art common curriculum to meet the regional or statewide training needs.
- Exercise leadership in the collaboration of interagency resources for the expansion of customized business and industry training statewide.

This consortium has been in existence since 1997. In the last two years (biennium 1999-2001) through the WorkForce Training Consortium, 93,004 workers were provided customized training - up 22% over the previous biennium. Those workers worked at 3,761 different companies - up 35% over the previous biennium and those workers were provided 1,694,780 contact hours of training - up 25% over the previous biennium.

Arkansas Association of Two-Year Colleges is currently funded from the General Improvement Fund with \$237,825 from the executive branch and anticipated \$123,250 (85%) from the legislative branch for the biennium. The Department requests this program be funded from General Revenue and the source of funding be tied to a new general revenue fund entitled Workforce Training Consortium. The Workforce Training Consortium fund is not to be considered part of the Departments' request for the financial aid programs or the general operating budget.

Request: Appropriation and Funding - \$180,538 for each year of the biennium 2003-2005.

ARKANSAS PERFORMANCE BUDGETING & ACCOUNTABILITY SYSTEM ANALYSIS OF BUDGET REQUEST 2003-2005

The Arkansas Department of Higher Education (ADHE) is requesting \$47,207,239 in appropriation and \$41,583,827 in funding for each year of the 2003-05 biennium for the Financial Aid & Scholarships Programs appropriation. Of these amounts, Change Level appropriations total \$6,123,412 each year. Change Level funding requests total \$500,000 for each year. This appropriation is currently funded from a combination of General Revenue, Higher Education Grants Fund balances, and Educational Excellence Trust funding, payable from the Higher Education Grants (HEG) Fund Account. The Change Levels are summarized as follows:

- (1) \$500,000 each year in appropriation and funding for the National Guard Tuition Assistance Program. This program is used to recruit and retrain qualified soldiers/airmen in the Arkansas National Guard. Requested funds will be used to help these young people pursue educational goals while serving their country in the National Guard. Higher Education Grants fund balances were used to fund this program during the 2001-03 biennium. According to ADHE, fund balances are expected to be depleted by the end of the current biennium and, therefore, will not available to fund this program for the 2003-05 biennium.
- (2) \$5,123,412 each year in appropriation only for the Governor's Scholars Awards Program. According to data collected by ADHE, the number of qualified high school students eligible for this program has increased by over 100% since 1997. Since the advent of the Governor's Distinguished Scholarship Program, the retention rate of top scholars remaining in the state for their college careers has increased from approximately 35% to 85%. Due to funding restraints, eligible high school graduates of 2002 were not offered the scholarship. For the 2003-05 biennium, it is anticipated that the new eligibility criteria established for the Academic Challenge Scholarship Program will produce savings sufficient to fully fund the Change Levels requested for the Governor's Scholars Program.
- (3) \$500,000 each year in appropriation only for the Non-Traditional Scholarships Program. This program is geared to serve the educational needs of residents over the age of 24 who are or wish to be college students, but cannot afford college due to lack of available financial aid. ADHE proposes to initiate the "Arkansas Workforce Improvement Grant Program" to target potential college students who are deemed "the working poor." Funds for this program would be allocated to institutions based on the school's previous year student enrollment, aged 24 or older. Based on a \$500,000

annual appropriation, it is projected that as many as 500 students could receive financial aid each year. Scholarships are projected to total up to \$1,800 annually for each student. ADHE plans to utilize a portion of the funds currently used for the Student Assistance Grant Program to fund this initiative.

(4) Reallocation of \$70,000 in appropriation from the Jr./Sr. Minority Teacher Scholarship Program to the Minority Masters Fellows Program. The Minority Master Program is designed to provide scholarships to African-American, Asian-American, Native-American, and Hispanic students who were recipients of the Minority Teacher's scholarship and are either entering a master's program or are in the fifth year of a five-year teacher licensure program. ADHE proposes to reallocate \$70,000 in appropriation only to more efficiently meet the needs of these students.

The Arkansas Department of Higher Education is requesting a total of \$180,538 in general revenue appropriation and funding for the 2-Year Workforce Training Consortium (WTC) for each year of the 2003-2005 biennium. All of the requests made for the new biennium for WTC are reflected as Change Level requests. The Consortium was established in 1997 and is comprised of all two-year colleges through the Arkansas Association of Two-Year Colleges. A primary function, among others, is to help facilitate the development of resources and capacity on the two-year campus to better serve business and industry through customized workforce training.

The WTC is currently funded from the General Improvement Fund. The Department requests this program be funded from general revenue and that the source of funding be tied to a new general revenue fund entitled "Department of Higher Education-Workforce Training Consortium". The Department also asks that funds requested for the WTC be considered as separate and apart from any other requests made for general operating or financial aid.

The Executive Recommendation denies the Agency Request and further recommends that funding for this program continue from the General Improvement Fund.

The Base Level request includes a 2.7% salary increase each year over the FY03 salary levels for all incumbents plus associated increases in Personal Services Matching. Included in Personal Services Matching is a \$33 per month increase in the monthly contribution for State employee's health insurance for a total state contribution of \$280 per month per budgeted employee. This program is federally funded through the U.S. Department of Education and supports services such as teacher education, preparation, recruitment, and professional development and licensure services.
