FISCAL YEAR GENERAL REVENUE SUMMARY

Fiscal Year 2015 Net Available General Revenues and Surplus: Fiscal year 2015 net available general revenue collections totaled \$5,250.5 million, \$228.1 million or 4.5 percent above last year. The resulting year-end surplus is \$191.6 million or 3.8 percent above the net available-for-distribution amount (budgeted) for fiscal year 2015. All categories of the general revenue budget were funded during the year.

The fiscal year ended above forecast and above the budgeted amount as a result of improving growth in gross revenue (collections) and lower-than-expected payouts from income tax refunds and other deductions. One-time deposits also influenced year ago comparisons.

Sales and use tax collections grew \$24.6 million or 1.1 percent over the year, including the effects of sales tax refunds of \$28.7 million in court settlement payments for sand and other proppants used in hydraulic fracturing for natural gas. Collections were \$14.9 million or 0.7 percent below forecast, due to the timing of the court settlement compared to the forecast release.

Individual and corporate income tax collections were above year ago results and above forecast. Together, these income tax components contributed \$83.5 million above forecast.

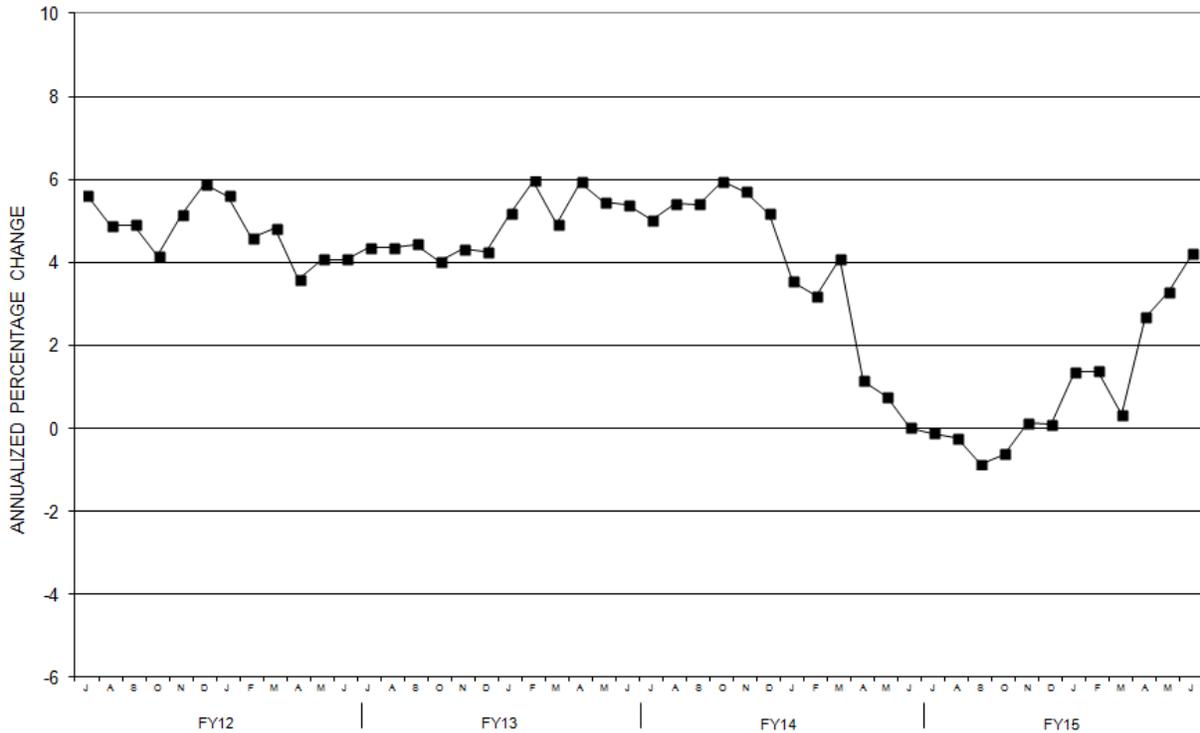
Among smaller collection categories, tobacco tax collections were below year ago collections and fractionally above forecast.

Notable one-time collections effects in FY 2015 consisted of \$14.4 million from a deposit from the Attorney General's Office and \$51.1 million from the Arkansas Insurance Department.

Fiscal Year 2015 Gross General Revenues totaled \$6,470.7 million, an increase of \$228.1 million or 3.7 percent above last year and \$72.3 million or 1.1 percent above forecast.

Net General Revenue Growth. Net general revenues, for purposes of the following graph only, are defined as gross general revenues less individual and corporate income tax refunds. For the twelve-month period ending in June, net general revenues totaled \$5,902.8 million and increased at an annual rate of 4.2 percent. One year ago, net general revenues increased by 0.01 percent.

Fiscal Year 2015 Individual Income Tax Collections totaled \$3,188.5 million, an increase of \$77.3 million or 2.5 percent above last year and \$67.4 million or 2.2 percent above forecast. Collections for individual withholding, the largest component of individual income tax, were \$2,443.8 million, an increase of 0.6 percent above last year. Withholding revenue was reduced by updated payroll withholding formulas at employers and payroll service companies starting in calendar year 2015, in addition to a small rate decrease from tax policy changes effective in January.

Fiscal Year 2015 Individual Income Tax Refunds totaled \$524.3 million, an increase of \$15.3 million or 3.0 percent above last year and \$0.4 million or 0.1 percent below forecast.

Fiscal Year 2015 Sales and Use Tax Collections totaled \$2,197.8 million, an increase of \$24.6 million or 1.1 percent above last year and \$14.9 million or 0.7 percent below forecast. Growth in sales tax collections accelerated in the final quarter, but results also reflect one-time refunds in sales tax from the court settlement on sand and other proppants used in hydraulic fracturing for natural gas. These refunds totaled \$28.7 million in FY 2015.

Fiscal Year 2015 General Revenue Corporate Income Tax Collections totaled \$493.1 million, an increase of \$52.9 million or 12.0 percent above last year and \$16.1 million or 3.4 percent above forecast.

Combined General and Special Revenue Corporate Income Tax Collections. For the twelve-month period ending in June, general and special net corporate income taxes totaled \$476.6 million and increased at an annual rate of 19.6 percent. One year ago, net corporate income taxes decreased at an annual rate of 1.1 percent.

JUNE REVENUE SUMMARY

June Net Available General Revenues totaled \$587.0 million, \$47.9 million or 8.9 percent above last year and \$58.9 million or 11.2 percent above forecast.

Net available funds in June were influenced primarily by one-time factors, mixed with positive underlying growth in major categories.

The one-time factors consisted of \$14.4 million from a deposit from the Attorney General's Office and \$51.1 million from the Arkansas Insurance Department.

The major income categories displayed mixed results for the month. Individual and corporate income tax exceeded the forecast and sales and use tax collections fell from year ago levels and forecast due to \$28.7 million in refunds issued in response to a court ruling.

June Gross General Revenues totaled \$670.3 million, an increase of \$53.9 million or 8.7 percent above last year and \$57.5 million or 9.4 percent above forecast.

June Individual Income Tax Collections totaled \$279.5 million, a decrease of \$7.3 million or 2.6 percent below last year and \$42.2 million or 17.8 percent above forecast.

June Individual Income Tax Refunds totaled \$32.3 million, an increase of \$17.3 million or 116.0 percent above last year and \$15.3 million above forecast.

June Sales and Use Tax Collections totaled \$159.4 million, a decrease of \$20.8 million or 11.5 percent below last year. Sales tax refunds processed in June included the court settlement of \$28.7 million for sand and other proppants used in hydraulic fracturing for natural gas.

June General Revenue Corporate Income Tax Collections totaled \$80.3 million, an increase of \$14.3 million or 21.6 percent above last year and \$14.1 million or 21.3 percent above forecast.

SPECIAL REVENUES OF NOTE

Special Corporate Income Taxes. Each month \$2.25 million (\$27.0 million total in FY 2015) in corporate income tax collections goes to *special* revenues. These revenues are not included in *general* revenue totals. They are allocated to the Work Force 2000 Fund, which provides for the upgrading of the post-secondary technical colleges of the state.

Soft Drink Tax (Medicaid Program Trust Fund). Fiscal year 2015 soft drink tax collections totaled \$41.9 million, a decrease of 4.5 percent below last year.

Conservation Fund. The state *general* sales and use tax rate is 4.5%. Effective July 1, 1997, Act 156 of 1997, the Conservation Fund Act, levied a one-eighth of one-cent increase in the sales and use tax rate as a *special* revenue. After deductions, the remaining money is distributed to the Game Protection Fund (45%), the Department of Parks and Tourism (45%), Arkansas Department of Heritage (9%), and the Keep Arkansas Beautiful Fund (1%). Effective with FY 2013, a portion of motor fuel taxes is also deposited to the Conservation Fund to offset the revenue loss from exempting truck tractors and semitrailers from sales tax. Fiscal year 2015 collections were \$67.3 million, an increase of 1.5 percent above last year.

Property Tax Relief Trust Fund. Acts 1 and 2 of the Second Extraordinary Session of 2000 levied a 0.5% increase in the sales and use tax rate effective January 1, 2001. This increase is *special* revenue dedicated to reimbursing Arkansas counties for the cost of homestead property tax credits created by Amendment 79 to the Arkansas Constitution. Effective with FY 2008, a portion of the 6-cent per gallon dyed diesel tax is deposited to the Property Tax Relief Trust Fund to offset the revenue loss from exempting dyed diesel from sales tax. Effective with FY 2013, a portion of motor fuel taxes is also deposited to the Property Tax Relief Trust Fund to offset the revenue loss from exempting truck tractors and semitrailers from sales tax. Fiscal year 2015 collections were \$246.1 million, an increase of 0.9 percent above last year.

Educational Adequacy Fund. Act 107 of the Second Extraordinary Session of 2003 increased the state sales and use tax rate from 5.125% to 6.0%, effective March 1, 2004. It also expanded the sales and use tax base to new services and increased the wholesale vending tax rate and decal fees, effective July 1, 2004. Act 94 increased the minimum corporate franchise tax and the tax rate, effective for calendar years beginning January 1, 2004. The additional revenues are deposited as *special* revenues to the Educational Adequacy Fund to be used to fulfill the financial obligations of the state to provide an adequate educational system. Effective with FY 2008, a portion of the 6-cent per gallon dyed diesel tax is deposited to the Educational Adequacy Fund to offset the revenue loss from exempting dyed diesel from sales tax. Effective with FY 2013, a portion of motor fuel taxes is also deposited to the Educational Adequacy Fund to offset the revenue loss from exempting truck tractors and semitrailers from sales tax. Fiscal year 2015 collections were \$474.6 million, an increase of 0.7 percent above last year.

Highway Fund. In November 2012, Arkansas voters approved Amendment 91 to the Arkansas Constitution, which levied a temporary 0.5% increase in the sales and use tax rate effective July 1, 2013. This increase is *special* revenue dedicated to four-lane highway improvements in Arkansas. The tax will be collected over an approximate ten-year period, and so long as the bonds issued for eligible road improvements remain outstanding. The maximum principal amount of bonds that can be issued under Amendment 91 is \$1.3 billion. This tax is distributed to the State Highway and Transportation Department Fund, the County Aid Fund, and the Municipal Aid Fund in the percentages provided in the Arkansas Highway Revenue Distribution Law (70% - 15% - 15%). Fiscal year 2015 collections were \$244.2 million, an increase of 9.3 percent above last year. The fiscal year growth is high because the prior year includes July 2013, the first month of the tax increase. Sales taxes are due to the State the month after their receipt by vendors. Since July 2013 was the first month in which the tax was effective, the State did not start receiving regular monthly collections until August 2013.

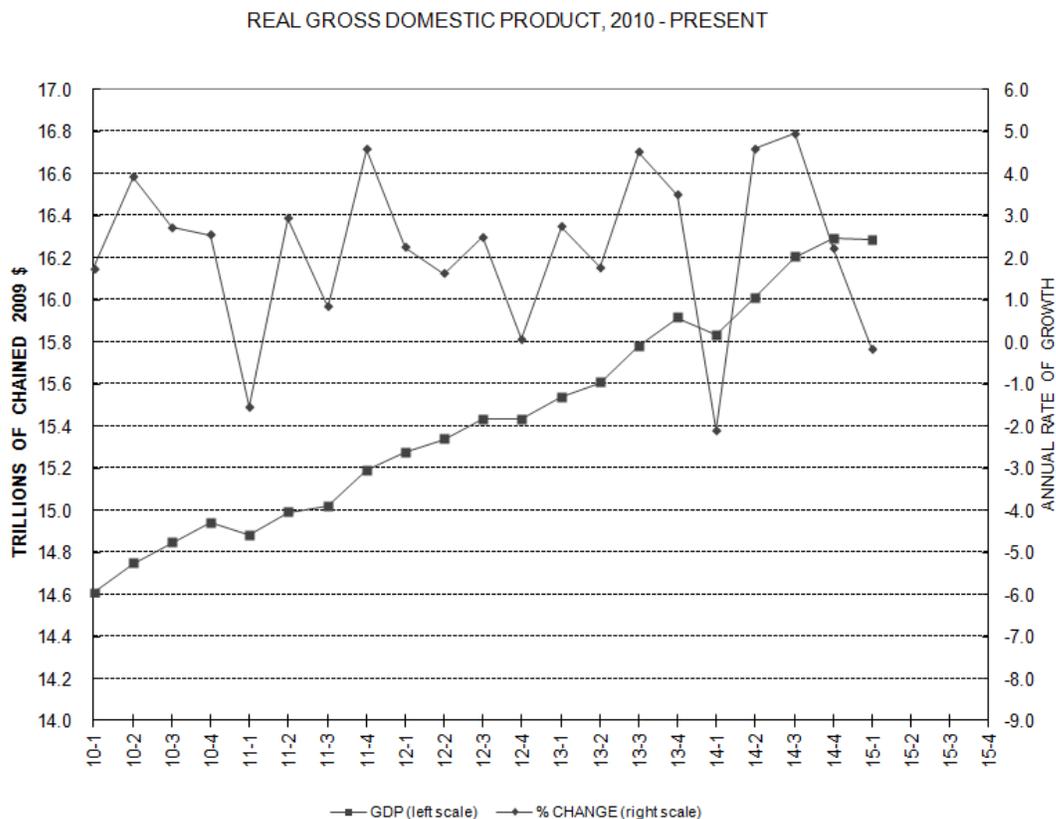
Most Recent Estimate of GDP Growth

Gross Domestic Product (GDP) is a measure of the nation's overall output of domestically produced goods and services. Quarterly estimates of GDP are released on the following schedule: Advance estimates, based on preliminary and incomplete source data and BEA assumptions about the missing source data, are released in the first month after the end of the quarter. "Second" estimates and "third" estimates, which incorporate additional and revised source data, are released in the second and third months, respectively.

The U.S. economy decreased at a 0.2 percent annual rate in the first quarter of 2015 according to the Commerce Department's "third" estimate for GDP growth. In the fourth quarter, real GDP increased 2.2 percent. The Department noted that "The decrease in real GDP in the first quarter primarily reflected negative contributions from exports, nonresidential fixed investment, and state and local government spending that were partly offset by positive contributions from personal consumption expenditures, private inventory investment, and residential fixed investment. Imports, which are a subtraction in the calculation of GDP, increased."

Quarterly estimates of GDP since the first quarter of 2010, and the annualized growth rates implied by these estimates, are displayed in the graph below.

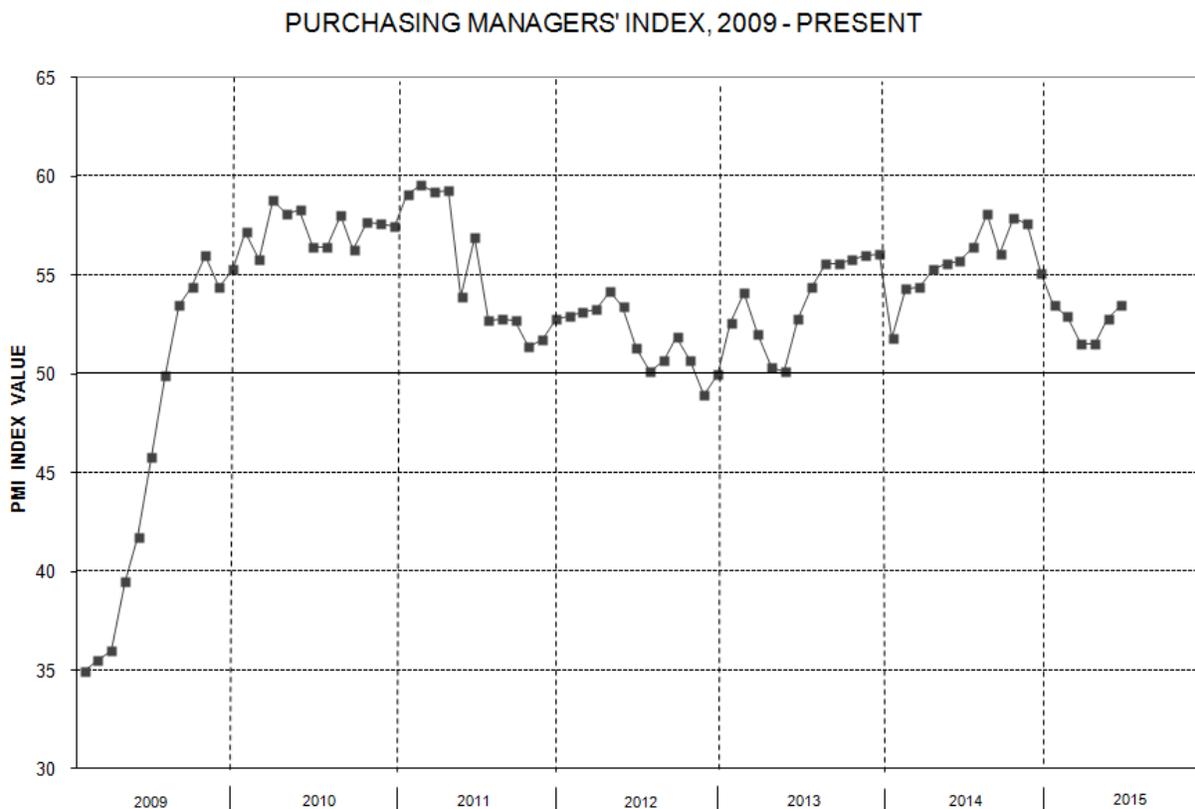


Institute for Supply Management's Purchasing Managers' Index (PMI)

The Institute for Supply Management reported that the Purchasing Managers' Index increased from 52.8 percent in May to 53.5 percent in June. "The June PMI registered 53.5 percent, an increase of 0.7 percentage point over the May reading of 52.8 percent. The New Orders Index registered 56 percent, an increase of 0.2 percentage point from the reading of 55.8 percent in May. The Production Index registered 54 percent, 0.5 percentage point below the May reading of 54.5 percent," reported Bradley J. Holcomb, CPSM, CPSD, chair of the Institute for Supply Management's Manufacturing Business Survey Committee.

The 50 percent mark is generally interpreted as the dividing line between growth and contraction in the manufacturing sector. According to the index, economic activity in the manufacturing sector expanded in June for the 30th consecutive month. The 43.1 percent mark is generally interpreted as the dividing line between growth and contraction in the overall economy. According to the index, the overall economy grew for the 73rd consecutive month. If the PMI for June is annualized, it corresponds to a 3.3 percent increase in real GDP annually.

The Purchasing Managers' Index is based on a nationwide survey of purchasing and supply executives in a variety of manufacturing industries. Membership of the Manufacturing Business Survey Committee is diversified by North American Industry Classification System (NAICS) code, based on each industry's contribution to gross domestic product (GDP). The PMI is a composite index based on five indexes with equal weights: New Orders, Production, Employment, Supplier Deliveries, and Inventories. The chart below tracks performance of the Purchasing Managers' Index since January 2009.



Labor Force Statistics, Arkansas and the U.S.

The U.S. Bureau of Labor Statistics reported that seasonally adjusted nonfarm employment for the nation increased by 223,000 in June. This follows a revised gain of 254,000 in May. In June, Construction employment was unchanged, while Manufacturing employment rose by 4,000. Wholesale Trade employment decreased by 200 while Retail Trade employment rose by 32,900. Employment in Financial Activities increased by 20,000. Health Care employment rose by 40,100. Employment in the Government sector was unchanged. The national unemployment rate fell from 5.5 percent in May to 5.3 percent in June. The current rate is below the 6.1 percent rate in June 2014.

In Arkansas, the Department of Workforce Services reported that nonfarm payroll employment (not seasonally adjusted) decreased by 3,100 from May to a level of 1,214,900 in June. Employment in Manufacturing increased by 400. Trade employment rose by 400 (+300 Wholesale, +100 Retail) on this seasonally unadjusted basis. Employment in Educational & Health Services fell by 1,400 while employment in Leisure & Hospitality decreased by 200. Government employment fell by 5,700. The State's seasonally adjusted unemployment rate decreased from 5.8 percent in May to 5.7 percent in June. The current rate is down from 6.1 percent in June 2014. The June state rate is 0.4 percentage points above the national rate. The state rate was equal to the national rate in June 2014.

Compared to June 2014, payroll employment in Arkansas is up by 23,400 in this preliminary estimate. The largest year-over-year gain of 5,900 occurred in Educational & Health Services. Manufacturing employment rose by 500 while Trade employment increased by 3,200 (+2,000 Wholesale, +1,200 Retail). Employment in Leisure & Hospitality rose by 4,400.

The graphs on the next page place Arkansas' employment growth patterns in a somewhat longer historical context. The upper graph shows the absolute level of nonagricultural employment in the state. The "actual" or unadjusted data show the seasonality of employment in the state, with sharp drops in employment occurring in January and July, while the "smoothed" data (12-month moving averages) reveal the underlying trends in employment.

The lower graph shows the percentage change in employment. The "actual" data represent the annual change from the same month one year ago to the current month. The "smoothed" data represent the annual change in the 12-month moving average. After accounting for seasonal factors, the annualized rate of employment growth in the state was 1.8 percent in June 2015. The data in these two graphs reflect the benchmark revisions made by DWS and BLS in January 2015 to the data for 2013 and 2014.

The table below places Arkansas' employment growth in comparative national perspective. For the 12-month period ending in June 2015, Arkansas' employment growth rate of 1.8 percent ranked 19th in the nation. The Arkansas rate was below the national growth rate of 2.2 percent.

FINANCIAL INFORMATION SOURCES STATE OF ARKANSAS

FINANCIAL ORGANIZATIONS & MANAGEMENT

The following state organizations share responsibility for statewide financial management: The General Assembly, the Office of the Budget and the Office of Accounting of the Department of Finance and Administration, the Governor, the Treasurer, and the Division of Legislative Audit.

The General Assembly has responsibility for legislating the level of state services and appropriating the funds for operations of state agencies. The Office of Budget prepares the Executive Budget with the advice and consent of the Governor. The Office of Budget also monitors the level and type of state expenditures. The Accounting Division has the responsibility for maintaining fund and appropriation control and, in conjunction with the State Treasurer, has responsibility for the disbursement process. The Treasurer has responsibility for disbursement, bank reconciliation, and investment of state funds (with the advice of the State Board of Finance). The Division of Legislative Audit has responsibility for performing financial post-audits of state agencies.

BUDGET AND APPROPRIATION PROCESS

State agencies submit biennial budget requests to the Office of Budget of the Department of Finance and Administration. The Office of Budget prepares the Executive Budget based on estimates of general revenues as prepared by the Office of Economic Analysis and Tax Research of DFA. The Executive Budget contains the budget amount recommended by the Governor.

The General Assembly appropriates money after consideration of both the Executive Budget and the revenue estimate. The appropriation process begins in the joint House-Senate Budget Committee and then proceeds through both houses of the General Assembly. Legislative appropriations are subject to the Governor's approval or veto, including the authority of line-item veto.

The General Assembly also must amend the Revenue Stabilization Act to provide for an allotment process of funding appropriations in order to comply with state law prohibiting deficit spending. The Governor may restrict spending below the level of appropriations.

REVENUE STABILIZATION LAW

Act 750 of 1973, as amended, established the State's Revenue Stabilization Law. This law and related legislation govern the administration and distribution of State revenues.

Pursuant to the Stabilization Law, all general and special revenues are deposited into the General Revenue Allotment Account and the Special Revenue Allotment Account according to the type of revenue being deposited. From the General Revenues Fund in FY2015, 3.2% of all general revenues are first distributed to the Constitutional Officers

Fund and the Central Services Fund to provide support for the States' elected officials and their staffs and the Department of Finance and Administration.

The balance is then distributed to separate funds proportionately as established by the Stabilization Law. From the Special Revenue Fund in FY2015, 3.2% of all special revenues collected by DFA and 1.6% of all special revenues collected by other agencies are first distributed to provide support for the State's elected officials, their staffs, and DFA. The balance is then distributed to the funds for which the special revenues were collected.

Special revenues, which are primarily user taxes, are generally earmarked for the program or agency providing the related services.

General revenues are transformed into funds established and maintained by the Treasurer for major programs and agencies of the state in accordance with fund priorities established by the General Assembly.

According to the Stabilization Law, the General Assembly establishes three levels of priority for general revenue spending. Successive levels of appropriations are funded only in the event sufficient revenues have been generated to fully fund any prior level. Accordingly, appropriations made to programs and agencies are only maximum authorizations to spend. Actual expenditures are limited to the lesser of (1) moneys flowing into a program or agencies' fund maintained by the Treasurer or (2) the maximum appropriation by the General Assembly.

Because state revenues are not collected throughout the year in a pattern consistent with program and agency expenditures, a budget revolving fund, which receives interest earnings for State fund investments, has been established and is utilized to assure proper cash flow during any period.
