In accordance with the provisions of Arkansas Code, §10-3-1404, I am notifying you of a revision to the Official Revenue Forecast on March 23<sup>rd</sup>, 2020.

A downward revision in the FY 2020 forecast of -\$353.1 million is now instituted as of this date. The forecast revision now reflects \$5,384.0 million in Net Available revenue for FY 2020.

This revision is necessary because of the extraordinary impact from business and consumer shutdowns and projected revenue shortfalls resulting from COVID-19 and the Governor's announced shifting of tax filing and payment deadlines.
