License Fee:

- * The initial license fee is to be submitted with the application.
- * Service Industry companies and Manufacturer/Distributor Companies On or before the 1st day of January for each subsequent year, a license renewal fee must be paid.
- * The employee license will be for a three (3) year calendar period, unless otherwise specified by the ARC. **Example:** License issued in March 2007, the three (3) calendar year life of this license would be 2007,2008, and 2009
- * License fees are non-refundable.
- * Failure to submit the initial license fee with the application will be just cause to reject the application.
- * Thereafter employee license fee is due within 60 days of the expiration date.

Application Fee:

- * The initial application fee is to be submitted with the application and is separate and apart from the license fee.
- * Application fees are non-refundable.
- * Failure to submit the initial application fee with the application will be just cause to reject the application
- * The applicant may be billed for actual costs of the background investigation that exceed the Application Fee.
- * Service Industry companies and Manufacturer/Distributor Companies On or before the 1st day of January for each subsequent year, a license renewal fee must be paid.
- * Thereafter employee license fee is due within 60 days of the expiration date.

Payment of Fees:

* The License Fee and the Application Fee can be paid together on one check, cashier's check, or money order.
