## Special Information

If you choose to file your State of Arkansas tax return by using one of the online web providers, you are required to complete and mail in the form AR8453-OL along with any W-2s or schedules that are required to the Arkansas E-File Section. This form is required to be sent to the E-File Section within 24 hours of receiving the State acknowledgement of receipt of the electronically filed tax return. **Failure to mail in the AR8453-OL will prevent you from using e-file to file your return in the future.**

Direct Deposit is offered on electronically filed Arkansas individual income tax returns. This is restricted to taxpayers who will receive their federal refund as a direct deposit. You must use the same account that is being used for direct deposit of the federal refund. Direct deposits will not be deposited into accounts outside the United States.

## Name and Address

If you received a mailing label from the State of Arkansas, place the label in the name area. If the information on the label is incorrect or you did not receive a label, print or type the information in the spaces provided. Enter your Social Security Number(s) (SSN) in the space(s) provided. An incorrect or missing SSN will delay any refund. If filing a joint return, be sure the names and SSN(s) are listed in the same order.

If the Post Office does not deliver mail to your home and you have a P. O. Box, enter the box number instead of the home address.

**Note:** The address must match the address shown on the electronically filed form AR1000F.

**Note:** All W-2(s) and 1099(s) must be attached to the AR8453-OL.

## Declaration of Taxpayer

An electronically transmitted income tax return will not be considered filed until the State of Arkansas has received a signed form AR8453-OL with W-2(s) and/or 1099(s) attached. If filing a joint return, your spouse must also sign.

## When to Mail

Mail the AR8453-OL and attachments (*W-2(s), 1099(s), and any additional required schedules*) to the Department of Finance and Administration on the next working day after you have received your State Acknowledgment (that the State has accepted your electronically filed return) from your on-line service provider and/or transmitter.

## Where to Mail

**If you have a tax due return, do not mail your payment with the AR8453-OL. See the Tax Due Information Section below.**

1. If you are mailing the AR8453-OL with copies of W-2(s) and/or 1099(s) only, mail to:

2. If you are claiming a credit for taxes paid to another state, filing the AR1000DC, AR1000RC5, AR1000-OD, or AR1113 Form(s) along with your W-2(s) and 1099(s), mail your AR8453-OL to:

## Notes on special schedules to be attached:

**If you are claiming an adjustment to income for a permanently disabled child,** attach the AR1000DC to the back of the AR8453-OL and mail to address 2 (above).

**If you are claiming the Other State Tax credit,** attach a copy of the tax return(s) from each state to the back of the AR8453-OL and mail to address 2 (above).

**If you are claiming the Developmentally Disabled Child Credit,** fax a copy of the AR1000RC5 to 501-682-7393. If you do not have access to a fax, attach a copy of the form to the back of the AR8453-OL and mail to address 2 (above).

**If you are claiming the Organ Donor Deduction,** fax a copy of the AR1000-OD to 501-682-7393. If you do not have access to a fax, attach a copy of the form to the back of the AR8453-OL and mail to address 2 (above).

**If you are claiming the Phenylketonuria Disorder Credit ,** fax a copy of the AR1113 to 501-682-7393. If you do not have access to a fax, attach a copy of the form to the back of the AR8453-OL and mail to address 2 (above).

## Refunds

After the State of Arkansas has accepted your electronically filed return, the refund should be issued within 7 to 10 business days.

## Tax Due Information

**Do Not** attach your check or money order to Form AR8453-OL. Do not mail a copy of your AR1000F/AR1000NR. Mail your payment with **Form AR1000-V** on or before April 15, 2011 to:
