AMENDMENT

TO RESOLUTION FIP-020C-07

TO EXERCISE THE OPTIONAL ONE-YEAR RENEWAL CLAUSE
FOR THE PERIOD OF APRIL 1, 2010 THROUGH MARCH 31, 2011

WHEREAS, pursuant to the agreement approved in Resolution #FI-0034-07 the County is authorized to work with National Intergovernmental Purchasing Alliance (National IPA) to secure multi-state volume purchasing contracts; and

WHEREAS, pursuant to that authorization the County issued its Request For Proposal #P07-001 (RFP) for a Master Contract Agreement for Systems Furniture, Freestanding Furniture, Seating, Filing Systems and Equipment and Related Support Services; and

WHEREAS, Resolution FIP-020-07 was approved and adopted by the County Board on March 27, 2007 making an award under RFP #P07-001 designating Corporate Express, Inc. (D/B/A Corporate Express Business Interiors) as a chosen vendor for all national contracts; and

WHEREAS, Resolution FIP-020A-07 amending Resolution FIP-020-07 was approved and adopted by the County Board on August 14, 2007; and

WHEREAS, Resolution FIP-020B-07 amending Resolution FIP-020A-07 was approved and adopted by the County Board on May 27, 2008; and

WHEREAS, Resolution FIP-020C-07 amending Resolution FIP-020B-07 was approved and adopted by the County Board on November 10, 2009; and

WHEREAS, the terms and conditions of RFP #07-001 allow for one (1) optional one-year renewal period provided there is no change in the terms, conditions, specifications, and provided that such renewals are mutually agreed to by both parties; and


WHEREAS, the County, Kimball Office, National Office Furniture and Staples Contract & Commercial, Inc. (D/B/A Business Interiors by Staples) are agreeable to exercising the one (1) optional one-year renewal period.

(D/B/A Business Interiors by Staples) as the chosen vendors for all national contracts is hereby renewed for the one (1) year period of April 1, 2010 through March 31, 2011.
