Total Cost of Acquisition: Please consider the concept of “total cost of acquisition” when utilizing this contract. Since Grainger offers next day, freight-free delivery on the majority of MRO supplies, agencies should re-evaluate existing inventory levels and any central warehousing and distribution programs. Grainger assumes this cost and function under this contract.

The contract has been competitively bid and covers all levels of purchases, including those over \$25,000.

Items covered by existing mandatory statewide or agency specific contracts, (Lamps, Ballasts, Air Conditioners, etc.), must be purchased from those contracts and are not to be purchased from the Grainger contract.
