
Please be aware that, under Section 4 of Executive Order 10-14, all vehicles must carry red, Official Business Only license plates and each must carry the official seal of either the State or your agency. Unless otherwise stated, this requirement applies to vehicles assigned to employees operating under a status designation of commuter.

Please also be aware that, under Section 3 of Executive Order 10-14, all vehicles not assigned to individual employees must be pooled, made available to any authorized employee and must remain on State property when not in use.

Additionally, please recall that Executive Order 10-14 requires State vehicles be used solely for purposes of official State business.

Dear Mr. Weiss:

I am writing this letter as my official request for an exemption or waiver from the Governor's Executive Order controlling the use of state-owned vehicles. I previously submitted my request for waiver and justification for commuter status, as attached.

One of the charges of the President of National Park Community College is to have more involvement in community activities and economic development for this area. In the fulfillment of these duties, there are numerous activities each week for which I find it necessary at various hours of day and night to attend and to represent NPCC's interests in the city and county. I frequently meet with prospective contributors and/or current contributors to the College Foundation about student scholarships and other needs for the College. As part of our Workforce Training Program, often we take representatives of prospective industry on tours of a multi-county area.

Many meetings are conducted over lunch or dinner for which I pick up the guests and take them to the destination. Our prospects and guests often do not want to ride around in a car displaying the state seal and red license plate identifying this as a state car. This can be a deterrent to a prospect feeling comfortable enough to choose our College for a contribution or for them to choose our county for a business or industrial site. When they are checking out an area, the workforce, and the training availabilities, they do not want to be seen as getting the cart before the horse in that it would appear they are bargaining with officials of the state and that would be making their identity and presence known before they are ready. The President's car, which is a Cheverolet Impala, without the state insignia on the side and with a regular white license plate would not be a cause for concern to a client not wishing to reveal too soon their identity, interest in a certain county or site, or their infrastructure needs.


On the issue of commuting, the "home to work" and "work to home" mileage in the NPCC President's state vehicle has been reported each year as an imputed taxable fringe benefit and is charged on the President's pay stub each pay period.

In addition to the regular daily College use, the President uses the car issued to her for evening and weekend events which are for College business. Many of these meetings, some local and some out of town, entail late evening returns after the College has closed. Having the commuting privilege allows the President to go on home in a much safer manner than if she had to come in the dead of night and unlock the gates behind which the automobiles are kept, enter and trade to her car, exit the gate, get out and lock the gate, then she could go home. This could pose a safety issue because NPCC is in the county and in a more remote location than many institutions.

In summary, I request the waiver or exemption from the President's car having to bear the State's seal and license plate. And, for the President's commuter status to remain as it has been for years, that is to be able to drive from home to work and work to home with the imputed fringe charged to the President.

Note: Home to work and work to home mileage using the state vehicle has been reported as an imputed taxable fringe benefit each year. That tax is charged on the President's pay stub each pay period.
