Bureau of Legislative Research- Operations

The Bureau of Legislative Research requests a total of \$11,916,983 for FY 2003-04 and \$11,997,004 for FY 2004-05 for salaries and operating expenses for the Bureau of Legislative Research. Maintenance and General Operations were increased by a 3% inflation factor. Fiscal Year 2003-04 operating expenses were based on FY 2001-02 actual expenditures and FY 2004-05 operating expenses were based upon FY 2002-03 budgeted expenditures. The budgeted amount for rent continued in the event that servers are moved off site due to security and environmental concerns. Extraordinary increases are included in Data Processing both fiscal years for pricing increases for internet services by the Department of Information Systems.

Personnel

The Bureau requests a total of 141 positions which is eleven more than the FY 2002-03 authorized level. Nine contingency positions were added in the event of the Bureau getting responsibilities not now contemplated. One new position is requested to oversee proofing, one Assistant Fiscal Officer position is requested due to additional workload and AASIS, and one position to be in charge of all database operations. Included in the request is to continue the current supplemental personal services position and delete two unneeded positions. The Legislative Analysts positions have been restructured to allow for a career path, and the Attorney Positions have also been restructured to create a senior leadership level and career path.

Legislative Council Disbursing Officer

The 2003-05 biennial request for the Joint Ad Interim Committee Study Expenses is 3% over the current authorized amount. The Joint AD Interim Committee Expenses appropriation has an 3% inflation factor increase for per diem, mileage and out-of-state travel for committees and their staff. The Energy Council appropriation has an 3% increase requested over 2002-2003 budgeted for expenses and for Arkansas' contribution.
