**DIVISION OF DEPENDENCY – NEGLECT REPRESENTATION (App.330):**

**Personnel:** The agency currently pays for attorneys who provide services to children through salaried positions and professional service contracts. The state's circuit judges determine the form of the employment relationship. The agency is requesting seven (7) new positions (but no additional funding) to accommodate judges who decide to move attorneys from contract positions to salaried positions. An increase of 2.7% to fund the current positions is requested.

**Operating Expenses:** The agency is requesting an increase of 3% for each year of the biennium to allow for ordinary growth and inflation.

**Grants and Aid:** The agency is requesting a continuation of \$1,000,000.00 each year of the biennium to fund local CASA program grants.

**Capital Outlay:** The agency is not requesting any capital outlay funding since all low value equipment will be funded from operating expenses.

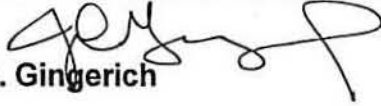
**Professional Fees:** The agency is requesting a 2.7% increase to pay attorneys who provide services to children on a full or part-time basis under a professional services contract.

**Legal Fees:** The Arkansas Judicial Council is requesting that the Domestic Relations and Probate ad litem appropriation be increased by \$150,000.00 each year of the biennium.

**Other Line Items:** No increases over the existing line items are requested by the agency for any other line items.

**STATE OPERATIONS (App. 343):**

**Personnel:** The agency is requesting an additional position of Spanish Language Interpreter, grade 24. The position will serve the courts in Northwest Arkansas, which is a high service demand area. The Administrative Office of the Courts is requesting an increase of 2.7% each year of the biennium.

Operating Expenses: The agency is requesting an increase of 3% each year of the biennium to allow for ordinary growth and inflation. The agency is requesting the transfer of \$139,500.00 from capital outlay each year of the biennium for the purchase of low value equipment for the agency (furniture, computers, etc.) and Circuit Judges (laptops and printers).

Capital Outlay: The agency is requesting a decrease to \$25,000.00 each year of the biennium to replace automobiles.

Other Line Items: No increase over the existing line items are requested.

ALTERNATIVE DISPUTE RESOLUTION (App.474):

Personnel: The agency is requesting 2.7% each year of the biennium.

Operating: The agency is requesting a 3% increase each year of the biennium for ordinary growth and inflation.

Other Line Items: No increase over the existing line item is requested.

JUDICIAL FINE COLLECTIONS (App.816):


Personnel: The agency is requesting that the funding for the Director of the State Automation Project be funded from this appropriation in lieu of past federal funding. This position is a grade 26.

Operating Expenses: The agency is requesting an increase of \$500,000.00 each year of the biennium to fund the cost of adding courts to the State Court Automation Project. This increase is necessary to fund the maintenance and operations of the system.

HEARING AND VISUAL IMPAIRMENT (App.817): No increase is being requested.

TRAINING AND REPRESENTATION – FEDERAL (App.966):

Personnel: The agency is requesting an increase of 2.7% each year of the biennium.

Operating Expenses: No increase is being requested.

Grants and Aid: The agency is requesting \$35,000.00 each year of the biennium to provide court technology grants to local ad litem offices.

Capital Outlay: The agency is requesting \$5,000.00 in capital equipment each year of the biennium to purchase office equipment over the capitalization threshold.

Other Line Items: No increase is requested.

COURT APPOINTED SPECIAL ADVOCATE (App.1DA):

Personnel: The agency is requesting a 2.7% increase both years of the biennium.

Other Line Items: No increase is requested.

DISTRICT JUDGES AND CLERKS EDUCATION (App.1EE): No increase above past-authorized levels are requested.

ACCESS AND VISITATION MEDIATION – FEDERAL (App.1JS): No increase above past-authorized levels is requested.


TRAINING/EDUCATION OF COURT PERSONNEL (App.832):

Operating Expenses: The agency is asking for an increase of \$25,000.00 each year of the biennium. This increase will allow increased training for ad litem, parent counsel, and other juvenile court staff.

DISTRICT COURT AUTOMATION SYSTEM (App.021): No increase above past-authorized levels is requested.

DISTRICT COURT AUTOMATION – COORDINATOR (App.032): No increase over existing line items being requested.


CONTINUING EDUCATION – DISTRICT JUDGES (App.158): No increase above past authorized levels is requested.
