ARKANSAS BUDGET SYSTEM ANALYSIS OF BUDGET REQUEST 1999 - 2001

Act 109 of 1969 established a three member Abstractor's Board of Examiners. The Board has the responsibility to regulate and license both abstract companies and individual abstractors of real estate titles. The Board schedules and administers a semi-annual examination to approximately 40 individuals seeking certification as a registered abstractor. Over 400 individuals and 130 firm licenses are issued and renewed each year.

Base Level includes a cost of living increase of 2.8% each year over the FY99 salary levels, related Personal Services Matching costs, and Operating Expenses for the Board. Total Base Level is \$24,156 in FY00 and \$24,669 in FY01. No changes are requested by the Agency for the next biennium.

The Executive Recommendation provides for continuation of Base Level. Expenditure of appropriation is dependent upon available funding.
