### ARKANSAS PERFORMANCE BUDGETING & ACCOUNTABILITY SYSTEM ANALYSIS OF BUDGET REQUEST 2003 - 2005

Arkansas Code Annotated § 17-17-201 authorizes the State Auctioneer's Licensing Board that consists of seven (7) members appointed by the Governor. The Board is responsible for promulgating rules and regulations, publishing annually a list of the names and addresses of all auctioneers licensed which includes names of all persons whose licenses have been suspended or revoked within the preceding year. Funding for the Board is derived from receipt of fees charged by the agency for examinations, licensing, renewals, and penalties. The Base Level request is \$144,242 in FY04 and \$145,257 in FY05. The Base Level request includes a 2.7% salary increase each year over the FY03 salary levels for all incumbents plus associated increases in Personal Services Matching. Included in Personal Services Matching is a \$33 per month increase in the monthly contribution for State employee's health insurance for a total state contribution of \$280 per month per budgeted employee. The change level request for \$3,500 in Capital Outlay is for the purchase of new computer equipment and is for the first year of the biennium only.

The Executive Recommendation provides for Base Level and the Agency Request for Capital Outlay of \$3,500 in the first year of the biennium.

Expenditure of appropriation is contingent upon available funding.
