The office vehicle is used solely by the Board auditor who travels to the audit sights. The vehicle is a 1997 model and has 110,000 miles.

The increase of \$4000.00 is to upgrade our computer equipment to keep pace with technological advancements.

The Arkansas Burial Association Board was created by Act 91 of 1953. The Board is a cash agency funded from the receipt of burial associated fees charged pursuant to Arkansas Code Annotated §23-78-111. The Board's responsibilities include the supervision of all burial associations organized or operating in this State.

The Base Level request includes a 2.7% salary increase each year over the FY03 salary levels for all incumbents plus associated increases in Personal Services Matching. Included in Personal Services Matching is a \$33 per month increase in the monthly contribution for State employee's health insurance for a total state contribution of \$280 per month per budgeted employee. Change Level requests are made for the first year only and are for a vehicle replacement (\$16,000) and equipment upgrades.

The Executive Recommendation provides for the agency request. Expenditure of appropriation is dependent upon available funding.
