# ARKANSAS PERFORMANCE BUDGETING & ACCOUNTABILITY SYSTEM AGENCY PROGRAM COMMENTARY 2003 - 2005

The Arkansas State Board of Cosmetology operates from two appropriations; Disciplinary Hearings (CO3) - a cash fund account and Cosmetology Operations (OS3) - a special revenue account.

### DISCIPLINARY HEARINGS (850) - FUND SOURCE (NBC0000)

This fund source is used for administrative hearing expenses (court reporter, subpoenas, witnesses' expenses, etc.,), the costs for other enforcement actions and related administrative expenses, (process servers, court fees, transcripts, postage, etc.,). The base level request for this appropriations is \$4,814. The Board is requesting continuation of its base level request in each year of the biennium. Anticipated receipts and the current fund balance in the Board's cash fund account are more than sufficient to support this request.

### COSMETOLOGY OPERATIONS (053) - FUND SOURCE (SXC0100)

The Board uses this fund source to cover operating expenses to conduct examinations; maintain a system for issuing certificates of registration and licenses; conduct health and safety inspections and operation audits; conduct meetings; maintain a principle office and provide the administrative support the Board needs to carryout its duties and responsibilities as prescribed in the Cosmetology Code.

An increase in the Board's bree level operation is remied to address the ever advancing IT requirements; upgrade office furniture and equipment, and to the property of increases in operating expenses needed to continue the Agency's level of operation. Consider the Property total (60,645 for FY 04 and \$87,360 for FY 05.

Anticipated receipts generated from operations 10%/0100) and the use of fund balances in the Board's Construction fund (SXD0000) and Cash Fund (MBC0000) are sufficient to support the Board's biennium budget request. Special language is requested to transfer \$108,400 from the Construction fund to the Operating fund to cover expenses to continue the Agency's lease agreement with ASBS for space to house the Board's office and examination facilities. Special language is also requested to transfer \$128,305 from the Board's Cash Fund to the Operating fund to cover the cost of the Information technology expenses. All other operating expenses will be covered by receipts generated from operation.

### IT Appropriation

Enhancements and upgrades for the IT equipment and software total an additional \$64,045 for FY 04 and \$64,260 for FY 05. This additional expense is necessary to replace obsolete computer equipment purchased in 1997; replace the FoxPro software licensing system that has become more costly to keep repaired; continue with maintenance on both the hardware and software; and purchase new computer equipment, handheld computers and the software to run them for the Inspection staff.

#### Capitol Outlay

An additional \$7,500 is requested in FY 04 and \$4,000 in FY 05 to replace desk chairs, mail room equipment, and a photo copier that were purchased in 1984, 1995 and 1996 respectively.

# ARKANSAS PERFORMANCE BUDGETING & ACCOUNTABILITY SYSTEM ANALYSIS OF BUDGET REQUEST 2003 - 2005

Arkansas Code Annotated §17-26-201 authorized the State Board of Cosmetology consisting of ten members appointed by the Governor. The members of the Board may not be directly or indirectly connected to the wholesale business of the manufacture, rental, sale, or distribution of cosmetological appliances or supplies. The Board is responsible for holding examinations, issuing certificates of registration and licenses, registering cosmetological establishments and schools of cosmetology, approving disbursement of funds, adopting rules and regulations, and enforcing the rules and regulations adopted. Funding is derived from special revenues received from the collection of license fees, and all funds remaining at the end of each fiscal year carry forward. This appropriation is utilized for the operating expenses for examinations, certifications, licenses, inspections, and all other Board related activities.

The Base Level request includes a 2.7% salary increase each year over the FY03 salary levels for all incumbents plus associated increases in Personal Services Matching. Included in Personal Services Matching is a \$33 per month increase in the monthly contribution for State employee's health insurance for a total state contribution of \$280 per month per budgeted employee. The Change Level requests include a small amount for CLIP increases, increases in Operating Expenses for IT upgrades, supplies, rent and postage, increases in Capital Outlay for a photo copier and IT enhancements, and IT maintenance increases in Data Processing. A special language request for fund transfers is noted in the funding portion of the Biennial Appropriation Summary report.

The Executive Recommendation provides for the agency request.
