The Board of Examiners in Counseling is requesting increases for the 2003-2005 budget years to effectively carry out the agency mission and responsibilities. The Board of Examiners in Counseling operates to protect the citizens of Arkansas at a cost only level and does not expect to have the fee increases different from the FY2003 fee schedule.

The budget requests reflect realistic projections for efficient operations of the Board and are summarized as follows: (1) Regular Salaries and Personal Services Matching for a Counseling Board Secretary I to establish an existing Supplemental Position. (2) Overtime to pay for hours worked over the maximum compensatory time allowed. Both requests are due to the increasing workload of the office.

Projected fee receipts will provide revenue to meet the costs of the budget requests.

ARKANSAS PERFORMANCE BUDGETING & ACCOUNTABILITY SYSTEM ANALYSIS OF BUDGET REQUEST 2003 – 2005

The Board of Examiners in Counseling is established under Arkansas Code Annotated § 17-27-201 and consists of eight (8) members appointed by the Governor. The Board is authorized to adopt rules, regulations and procedures to carry out the duties authorized; is required to adopt the Code of Ethics of the American Counseling Association and any revisions or additions deemed appropriate by the board to govern appropriate practice or behavior relative to counseling services; is required to adopt the Code of Ethics of the American Association of Marriage and Family Therapy to govern licensed marriage and family therapists and licensed associate marriage and family therapists; and is required to charge an application fee determined by the board. Additionally, the Board is authorized to accept grants from foundations and institutions to carry out its functions and hire assistants as are necessary to perform its activities. The Board has purview over Professional Counselors, Associate Counselors, Marriage and Family Therapists, Associate Marriage and Family Therapists. Arkansas Code annotated §17-27-313 requires that each first-time applicant for a license issued by the Arkansas Board of Examiners in Counseling apply to the Identification Bureau of the Department of Arkansas State Police for a state and national criminal background check to be conducted by the Federal Bureau of Investigation.

This appropriation authorizes expenditures for all operations of the Board to include the administration of examinations and licensure. The Board processes its payroll through the State Treasury, but maintains all other operating funds in a financial institution. Fees are collected from initial licensure and biannual renewal of licenses.

The agency Base Level request for this appropriation is \$155,548 in FY2004 and \$156,887 in FY2005 with two (2) budgeted Base Level positions. The Base Level request includes a 2.7% salary increase each year over the FY2003 salary levels for all incumbents plus associated increases in Personal Services Matching. Included in Personal Services Matching is a \$33 per month increase in the monthly contribution for State employee's health insurance for a total state contribution of \$280 per month per budgeted employee.

The agency Change Level request for this appropriation is \$31,695 for FY2004 and \$32,365 for FY2005. This request consists of one (1) new Counseling Board Secretary I with salary and matching appropriation and the establishment of an Overtime line item in the amount of \$3,000, for each year of the biennium.

The Executive Recommendation provides for the Base Level request and the Counseling Board Secretary I with salary and associated matching appropriation for each year of the biennium. Expenditure of appropriation is contingent upon available funding.
