
# Enabling Laws

Act 1285 of 2005 A.C.A. §16-123-302

# History and Organization

The Arkansas Legislature created the Arkansas Fair Housing Commission by Act 185 of 2001. The mission of the Commission is to receive, investigate, conciliate and/or resolve complaints alleging violations of the Arkansas Fair Housing Act, which prohibits housing discrimination on the basis of race, religion, color, sex, national origin, familial status or disability; to cooperate with and provide technical and other assistance to federal, state, local and other public or private entities that are formulating or operating programs to prevent or eliminate discriminatory housing practices; and to establish an education and outreach program to prevent discriminatory housing practices.

The Commission is composed of thirteen members. Seven are appointed by the Governor, three by the President Pro Tempore of the Senate and three by the Speaker of the House. Six of the appointees are industry representatives and seven are consumers. Each Congressional District must be represented by a Commissioner.



# Agency Commentary

The Arkansas Fair Housing Commission (AFHC) was created in 2001 for the purpose of:

- Receiving, investigating, conciliating and/or resolving complaints alleging violations of the Arkansas Fair Housing Act, which prohibits discriminatory housing practices in lending, appraisal, sale, rental and occupancy based on seven (7) identified prohibited bases: race, color, religion, sex, national origin, familial status and disability.
- Assisting other entities (both public and private) in the formulation and operation of programs that prevent or eliminate discriminatory housing practices.
- Providing for an education and outreach program to prevent discriminatory housing practices.

## Fund Center: 1NH (State Operations)

Base level appropriation is authorized in the amount \$282,129 in each year with general revenue funding in the amount of \$116,772 in each year.

The Agency requests Change Levels as follows:

### 00-Regular Salaries

Increase in appropriation and general revenue funding in the amount of \$27,629 for one new Investigator position. This position is necessary to ensure that the Agency carries forth the legislative declaration reflected in A.C.A §16-123-301 that, "the right to seek housing underlies the general public's ability to secure health, safety and welfare." The Arkansas Fair Housing Commission was established to support that legislative dictate to resolve fair housing issues and enforce the fair housing laws within the State. The passage of the Arkansas Fair Housing Act gained the State of Arkansas recognition as being a "substantially equivalent" agency, meaning that the state law provided substantially the same protections as the federal law - thereby granting Arkansas the avenue to enforce our own fair housing law within our borders without federal intervention.

As part of the "substantially equivalent" process, the Agency is required to complete a three-year "capacity-building" phase during which time the Commission partners with the U.S. Department of Housing and Urban Development (HUD) via a cooperative agreement to receive, investigate and conciliate fair housing complaints within Arkansas. The Commission will "graduate" in FY2007 to a "contribution agency" status with the responsibility of processing all fair housing violations within the State.

During this mandatory three-year "capacity-building" period, the Commission investigated a portion of the State's fair housing complaint caseload with HUD investigating the bulk of the fair housing complaints and providing technical assistance in support of our limited enforcement efforts. In FY2006, this Agency received approximately 200 fair housing complaints for alleged infractions occurring within the State's borders (this number does not include those complaints generated in Arkansas that were received and processed solely by HUD). The number of complaints the Agency processes is expected to substantially increase once we become a "contribution agency."

As part of the Agency's cooperative agreement with HUD, the Agency is slated to become a "contribution agency" in FY2007 and will be responsible for 100% of case processing for all fair housing complaints occurring within the State's borders. Currently, the Agency employs only two (2) investigators to cover the State's nearly three million residents (2,779,154 according to the U.S. Census Bureau) within 75 counties. HUD currently employs ten (10) full-time investigators who process fair housing complaints within Arkansas, the majority of whom are housed in Texas and have no personal knowledge of Arkansas and its residents. An additional investigator is necessary to handle the anticipated increased caseload when HUD ends its case processing in Arkansas and transfers all fair housing case processing to this Agency.

### 03-Matching

Increase in appropriation and general revenue funding in the amount of \$10,544 for personal services/matching increases associated with the new Investigator position.

#### 02-Operating Expenses

Increase in appropriation and general revenue funding in the amount of \$4,000 for office supplies necessary to support the new Investigator position (such as a computer, a desk/chair, an additional telephone line, general office supplies and mileage allowance for investigative travel). Additionally, this request is necessary to accommodate an anticipated increase in investigative travel overall due to the additional case processing mandated by HUD. Accordingly, this appropriation will aid in our fulfillment of the cooperative agreement with HUD to furnish all necessary personnel, materials, services, equipment, facilities and otherwise do all things necessary for or incidental to the performance our agreement.

### 02-Operating Expenses

Increase in appropriation and general revenue funding in the amount of \$14,000 for increased rent expenses anticipated by the Agency. This increase will result from the Agency's anticipated move into a larger office space located within the Main Street Mall. This move is necessary to accommodate the existing and additional staffing needs. The Agency is currently housed in a two-office suite within the Main Street Mall. At the time the Agency was created, only two of the four positions were filled; thus, the office accommodations were then sufficient for the staffing. The Agency is now fully staffed and requires additional office space to accommodate personnel and file/storage needs. The Agency has located a four-office suite within the Main Street Mall that would accommodate the office and staffing needs.

## Fund Center: NEW (Arkansas Fair Housing Commission Trust Fund)

The Agency requests to create a new fund center with appropriation in the amount of \$50,000 for the Arkansas Fair Housing Commission Trust Fund. This fund was established in 2001 (A.C.A. §16-123-347) for the purpose of receiving any administrative or civil penalties levied and collected to be solely used for fair housing education of the public and the operational expenses of the commission.

The Agency requests Change Levels as follows:

### 02-Operating Expenses

Increase in appropriation only in the amount of \$50,000 for education/outreach and operation of the Commission. This appropriation is necessary to utilize administrative and/or civil penalties levied and collected pursuant to the Arkansas Fair Housing Act to provide for the fair housing education of the public and for the operational expenses of the Commission as mandated by the Legislature.

The Commission anticipates the establishment of a fair housing media campaign to include: public service announcements (audio and video); television, radio and print advertisements; posters; pamphlets and brochures. The Commission also will work with public and private service organizations and agencies to establish a state-wide media campaign and to establish educational training programs for industry personnel and the public at large. As required by law, this training and education will be disseminated in compliance with the adaptability and accessibility guidelines.

## Analysis of Budget Request

Appropriation:	1NH - State Operations
Funding Sources:	HUA - Miscellaneous Agencies Fund

The Arkansas Fair Housing Commission (AFHC) was created in 2001 to investigate housing discrimination complaints and punish violators, in cooperation with the State Attorney General.

The Agency's Base Level request is \$282,129 each year of the biennium with general revenue funding in the amount of \$116,772 each year and four (4) regular positions. A cost of living increase is not incorporated in Base Level pending the outcome of the Classification and Compensation Study. The Base Level request of \$149,137 each year for Regular Salaries does include board member Stipend payments. FY07 salary levels have been held flat each year for all incumbents. Personal Services Matching reflects increases in the Base Level due to certain increases in Worker's Compensation rates. Personal Services Matching also includes a \$30 increase in the monthly contribution for State employee's health insurance for a total State match per budgeted employee of \$350/month.

The Agency Change Level Request includes additional appropriation and general revenue funding in the amount of \$56,173 each year and is comprised of the following:

**Regular Salaries and Personal Services Matching:** Increase of \$38,173 each year for one new grade 19 Investigator position. Currently the Agency partners with the US Department of Housing and Urban Development (HUD) to receive, investigate and conciliate fair housing complaints within Arkansas. However, as part of the Agency's cooperative agreement with HUD, the AFHC is scheduled to take over the processing of all of the State's fair housing complaints, including those currently performed by HUD. This new position is necessary to enable the Agency to handle the resulting anticipated increase in caseload.

**Operating Expenses:** Increase of \$18,000 each year for the following:

- \$4,000 for increased operating expenses associated with the new Investigator position, including office supplies and mileage reimbursement as well as for increased mileage reimbursement for all current Investigator positions due to increased investigative travel related to the anticipated increase in caseload.
- \$14,000 for increase rent expenses related to the Agency's anticipated move to a larger office space to accommodate the existing and additional staffing needs. When the Agency is fully staffed with the four (4) current positions and the one (1) requested additional position, the current office accommodations are not considered by the Agency to be adequate to accommodate the staffing, filing and storage needs of the Agency.

The Executive Recommendation provides for the Agency Change Level Request for Operating Expenses with no additional general revenue funding.

## Analysis of Budget Request

Appropriation:	4KX - FHC-Trust Operations
Funding Sources:	TFH - Arkansas Fair Housing Commission Trust Fund

The Arkansas Fair Housing Commission Trust Fund was established in 2001, and is authorized by ACA §16-123-347 to consist of the following:

- Funds received by the Arkansas Fair Housing Commission, and any other moneys as may be provided by the General Assembly, there to be used for the administration and operations of the commission; and
- Any administrative or civil penalty levied and collected pursuant to this subchapter to be solely used for fair housing education of the public and the operational expenses of the Commission.
- The appropriation to the Arkansas Fair Housing Commission providing for "public education" may be used to fund all expenses incurred in conducting educational seminars and other forms of educational projects for use and benefit generally of the public, including the production and distribution of information literature of an educational nature.

No Base Level appropriation is authorized because this trust fund was not appropriated for the 2005-2007 biennium. The unappropriated trust fund balance that carried over from FY06 to FY07 was \$4,500.

The Agency Change Level Request is to establish appropriation for Operating Expenses in the amount of \$50,000 to enable the Agency to expense both the current and the anticipated increases in available funding. The Agency expects funding to increase due to the impending transfer of all fair housing case processing within the State of Arkansas from the U.S. Department of Housing and Urban Development (HUD) to the Arkansas Fair Housing Commission (AFHC). This appropriation will be utilized to supplement operational expenses of the Agency and to provide fair housing education to the public, including the establishment of a state-wide media campaign and training programs for industry personnel and the general public.

The Executive Recommendation provides for appropriation in the amount of \$10,000 each year.
