

History and Organization

The Arkansas Legislature created the Arkansas Fair Housing Commission by Act 185 of 2001. The mission of the Commission is to receive, investigate, conciliate and/or resolve complaints alleging violations of the Arkansas Fair Housing Act (the Act prohibits discrimination on the basis of on race, religion, color, sex, national origin, familial status or disability); to cooperate with and provide technical and other assistance to federal, state, local and other public or private entities that are formulating or operating programs to prevent or eliminate discriminatory housing practices; and to establish an education and outreach program to prevent discriminatory housing practices.

The Commission is composed of thirteen members. Seven are appointed by the Governor, three by the President Pro Tempore of the Senate and three by the Speaker of the House. Six of the appointees are industry representatives and seven are consumers. Each Congressional District must be represented by a Commissioner.



Agency Commentary

The Arkansas Fair Housing Commission respectfully requests an adjustment of funds transferring \$10,000.00 from Travel and Conferences to Operating Expenses. There are several reasons for this transfer. First, the increased operating expenses are due to the increase in travel. This agency serves the entire State of Arkansas and must travel to all corners. As the Agency's case load grows its need to travel increases. This increase would be needed even if gasoline prices were not high. Second, many of the Agency's education and conferencing needs have been met in the first years of existence and will, therefore, be reduced in the future. Finally, the Agency spends some \$24,000.00 per year in stipends and traveling expenses for its Commission members. (The Agency has thirteen [13] members.) As the Agency grows, it may be necessary to have longer meetings over more than one day or additional meetings. Ideally, it may be better to reduce the number of required meetings. In the meantime, additional funds are needed.

Analysis of Budget Request

Appropriation / Program: 1NH - State Operations

Funding Sources: HUA - Miscellaneous Agencies Fund

The Arkansas Fair Housing Commission was created by Act 1785 of 2001. The Commission is authorized to investigate housing discrimination complaints and punish violators, in cooperation with the State Attorney General.

Base Level for this appropriation includes graduated salary increases of 3% to 1.5% each year over FY05 salary levels, along with related Personal Services Matching costs for four (4) Base Level positions. This includes a \$600 minimum increase for employees earning \$20,000 or below. Included in Personal Services Matching is a \$40 increase in the monthly contribution for State employee's health insurance for a total State match of \$320 per month.

The agency is requesting an increase of \$10,000 each year in Operating Expenses to cover increased mileage for the Commission members. A decrease of \$10,000 each year in Travel is requested to offset the increase in Operating Expenses due to more mileage being spent as official business travel.

The Executive Recommendation provides for the Agency Request.
