The Arkansas State Board of Registered Interior Designers is requesting a decrease in appropriation for the 1999-2001 biennium. As a result of the increase of the extra help appropriation for FY99, the Board anticipates its balance to be \$1,000.00 on June 30, 1999. With receipts estimated at \$2,600.00, the Board is budgeting \$3,528.00. The budget has been adjusted in extra help, operating expenses, and matching fund categories.

CASH TRANSACTIONS - Review of the cash transactions for the two bank accounts of the State Board of Registered Interior Designers revealed the following:

- a. (Inadequate documentation for receipts and timely deposit of cash was retained for audit.) The only record of the receipt of cash totaling \$3,240.00 provided for audit was the listing of checks written on bank deposit tickets.
- b. (A cash receipts journal to classify fee revenue was not retained for audit.)
- c. (All transactions of the Agency were not recorded in the Accounting Federal Grants Management (AFGM) System.) The transactions of the State Board of Registered Interior Designers donation cash fund for the year ended June 30, 1996, consisted only of operating expenditures of the Agency totaling \$740.00, thereby making the transactions subject to the provisions of the General Accounting and Budgetary Procedures Law.
- d. The AFGM Fund Analysis Report was not being reconciled monthly to the true cash balances of the Agency.
- e. (Travel Expense Reimbursement Forms (TR-1) were not used as part of the documentation of board member travel expenses.)

The General Accounting and Budgetary Procedures Law and the State Accounting Procedures Manual require State agencies to properly account for all cash fund transactions.

ARKANSAS BUDGET SYSTEM ANALYSIS OF BUDGET REQUEST 1999 - 2001

The Arkansas State Board of Registered Interior Designers is charged with the responsibility of regulating and registering interior designers in the State of Arkansas. The Board receives income from fees collected for information, application, and registration fees.

During FY99, the Extra Help was increased from \$2,000 to \$4,000 due to an increased workload. Included in Base Level is Operating Expenses as well as one extra help position that provides secretarial support and processes annual dues. The Board anticipates an income reduction in the 1999-01 biennium due to the increase in Extra Help for FY99, the Board's decision to abolish certain fees, and the number of renewals decreasing. The Board is requesting a reduction in its operating appropriation from \$6,648 to \$3,528 each year of the biennium to offset this income reduction.

The Executive Recommendation provides for Base Level. Expenditure of appropriation is dependent upon available funding.
