## **History and Organization**

The Arkansas General Assembly saw the need to regulate the practice of engineering. They passed Act 202 of 1925 to create the Agency. A Board was established to review the qualifications of individuals to insure they met certain minimum qualifications to be awarded a license to practice engineering in the State of Arkansas. The Board was also given the authority to discipline individuals that provided substandard engineering services to residents of the State. The original Act has been amended numerous times and at present is A.C.A. §17-30-101 et. seq.

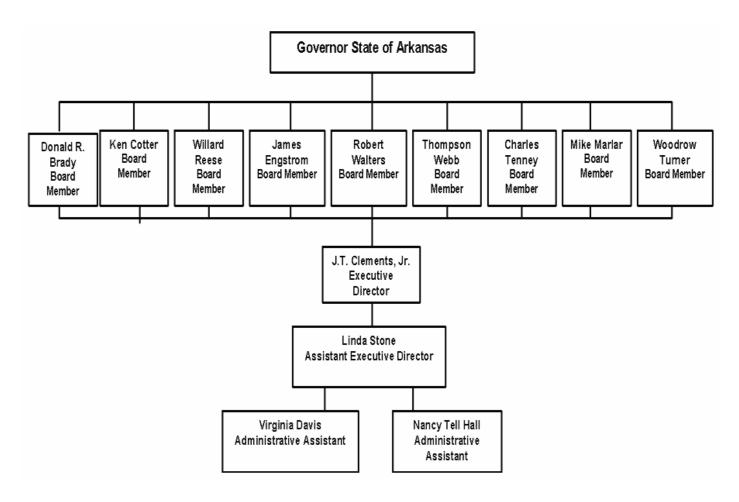
Act 101 of 1967 was passed by the General Assembly which added to the Agency the licensing of Land Surveyors. The Board reviews the qualifications of individuals to be awarded a license to practice Land Surveying in the State of Arkansas. The Board was also given the authority to discipline individuals that provide substandard Land Surveying services to residents of the State. The original Act has been amended numerous times and at present is A.C.A. §17-48-101 et. seq.

The Agency has never received any money from the State for the operation of the office. All monies used by the Agency for operation, salaries, and etc. are generated from the collection of application fees, examination fees, renewal fees and disciplinary civil penalties.

The Board consists of nine (9) members that are appointed by the Governor. Five (5) members shall be Professional Engineers of at least ten (10) years of active experience, of good standing in their profession, and registered as Professional Engineers at the time of their appointment; One (1) member shall be a Professional Engineer and a Professional Land Surveyor of at least ten (10) years of active experience in both, of good standing in both professions and registered as both a Professional Engineer and Professional Land Surveyor, at the time of their appointment; One (1) member shall be a Professional Land Surveyor of at least ten (10) years active experience, of good standing in their profession, and registered as a Professional Land Surveyor at the time of his appointment; Two (2) members of the Board shall not be actively engaged or retired as a Professional Engineers or a Professional Land Surveyor, One (1) shall represent consumers, and One (1) shall be at least sixty (60) years of age and shall represent elderly consumers. The term of office for each appointment is four (4) years. There is no restriction on the number of times an individual may be appointed.

The Agency is staffed at the present time by four (4) individuals and one (1) extra help position. They are an Executive Director, Assistant Executive Director, and two (2) Administrative Assistant II. The extra help position is being used as a Complaints Coordinator/Investigator. The staff is

responsible for compiling all information necessary for the Board to make decisions on the licensing of individuals. Other responsibilities include, maintaining records of all renewals, correspondence, and financial records of the Agency.



# **Agency Commentary**

This agency has experienced increases of \$16,000 each year of the current biennium for the purchase and grading of the national examination. The agency is estimating this cost to increase to \$21,000 above the Base Level budget during the upcoming biennium. The exam is given twice each year. In addition, the Board has conducted 5 special meetings for the purpose of disciplinary hearings in an effort to reduce the number of outstanding complaints as well as the length of time between the filing of a complaint and its final resolution. This level of activity is expected to continue through FY07 at an additional cost of \$10,000 per fiscal year. We are anticipating an increase in the annual rent of our office space of at least \$7,500 per year during FY06 and FY07. Our annual dues to the National Council of Examiners for Engineers and Surveyors has been increased by \$1,000 per year beginning with FY05. In FY07, we expect to replace 5 computer workstations and update our software as a 5-year life cycle cost of \$6,000. The increase in Data Processing cost of \$750 per fiscal year is based upon published rates from DIS (\$350) and estimated cost by the website contractor of (\$400).

## **Analysis of Budget Request**

**Appropriation / Program:** 857 - Lnd Surveyors-Cash in Treasury

**Funding Sources:** NES - Cash in Treasury

Act 202 of 1925 created the Arkansas State Board of Registration for Professional Engineers and Land Surveyors. The purpose of the Board is to insure the public through regulations that professional engineers or land surveyors will provide competent services to the citizens of the State. The Board is funded from application, certificate, and renewal fees charged pursuant to Arkansas Code Annotated §17-30-304.

Base Level for this appropriation includes graduated salary increases of 3% to 1.5% each year over FY05 salary levels, along with related Personal Services Matching costs for four (4) Base Level positions. Included in Personal Services Matching is a \$40 increase in the monthly contribution for State employee's health insurance for a total State match of \$320 per month.

The Board is requesting an increase in the Operating Expenses line item of \$40,500 in FY06 and \$46,500 in FY07. The request is for Board Member expenses, examinations, dues, and rent. The Board has had five extra meetings in FY04 at a cost of \$2,000 per meeting. The Board is also experiencing increased costs for the purchase and grading of the national examination. The exam is given twice a year, and the costs are estimated at \$21,000 above the base level budget for FY06 and FY07. The Board's annual dues to the National Council of Examiners for Engineers and Surveyors has increased \$1,000 per year. The Board is also anticipating an increase in rent of at least \$7,500 per year. The Data Processing line item request of \$750 each year is based upon published rates from DIS and estimated cost by the website contractor.

The Executive Recommendation provides for the Agency Request.

#### **Justification**

The increases are for Board Member expenses, examinations, dues, and rent.
