#### ARKANSAS BUDGEI SYSIEM AGENCY PROGRAM COMMENTARY 1999 - 2001

The Board has recognized 1,809 registered geologists, 1,165 having a current status. There are 5 Geologists-in-Training, and currently 14 applications for registration on file. The Board is authorized to collect up to \$60.00 per year, per registrant in renewal fees however, currently the annual renewal fee is set by the Board at \$30.00 for registered geologists. Other fees collected include \$60.00 initial annual fee, \$20.00 application fee, \$20.00 renewal fee for Geologists-in-Training. In addition, penalty fees at the rate of 50% are charged to those fees paid during a six-month penalty period. Fees paid after penalty period are doubled.

The Board is located at the Geological Commission office that provides office space and administrative assistance. The revenue from registration and other fees supports salaries and supplies.


No request for additional funds for salaries and personal services matching is being requested.

Capital outlay for FY2000 in the amount of \$3,800 for updating data processing equipment and data processing software is requested. FY2001 will require no request of capital outlay.

An additional \$1,500 per year of the biennium is requested to cover travel and fees incurred attending training conferences and a national association convention.

## ARKANSAS BUDGET SYSTEM ANALYSIS OF BUDGET REQUEST 1999 - 2001

The Board of Registration for Professional Geologists was created by Act 701 of 1987. The Board is a cash agency funded from the receipt of fees charged pursuant to Arkansas Code Annotated §17-32-307. The primary duty of the Board is to regulate the practice of geology in the State of Arkansas in the public sector. The FY99 budgeted amount of \$79,151 consists of Regular Salaries and Personal Services Matching for two positions (Business Controller and Clerk Typist), Operating Expenses and Conference Fees & Travel. The Board is provided office space and administrative assistance by the State Geological Commission. Base Level is \$80,703 for FY00 and \$81,901 for FY01 and includes a cost of living increase of 2.8% each year over the FY99 salary levels, and related Personal Services Matching.

Listed below are the change level requests of the Board totaling \$5,300 for FY00 and \$1,500 for FY01:

**Conference Fees & Travel** - \$1,500 for each year allow the Business Controller to attend the National Association of State Boards of Geology convention.

Capital Outlay - \$3,800 For FY00 to allow for the purchase of a computer with Internet access and printer
