### ARKANSAS BUDGET SYSTEM AGENCY PROGRAM COMMENTARY 2001 - 2003

The Board has recognized 1,823 registered geologists, 909 having a current status. There are 5 Geologists-in-Training, and currently 3 applications for registration on file. The Board is authorized to collect up to \$60.00 per year, per registrant in renewal fees; however, currently the annual renewal fee is set by the Board at \$30.00 for registered geologists. Other fees collected include \$60.00 initial annual fee, \$20.00 application fee, \$20.00 renewal fee for Geologists-in-Training. In addition, penalty fees at the rate of 50% are charged to those fees paid during a six-month penalty period. Fees paid after the penalty period are doubled and require reinstatement by the Board.


The Board is located at the Geological Commission office in Little Rock that provides office space and administrative assistance. The revenue from registration and other fees supports salaries and supplies.

No request for additional funds for salaries and personal services matching is being requested.

A Capital Outlay of \$2,500 in FY02 and \$2,000 in FY03 is requested for updating data processing equipment.

# ANALYSIS OF BUDGET REQUEST 2001 - 2003

The Board of Registration for Professional Geologists was created by Act 701 of 1987. The Board is a cash agency funded from the receipt of fees charged pursuant to Arkansas Code Annotated §17-32-307. The primary duty of the Board is to regulate the practice of geology in the State of Arkansas in the public sector. The FY01 budgeted amount of \$82,845 consists of Regular Salaries and Personal Services Matching for two positions (Business Controller and Clerk Typist), Operating Expenses and Conference Fees & Travel. The Board is provided office space and administrative assistance by the State Geological Commission. The Agency Request for Base Level is \$84,013 for FY02 and \$85,183 for FY03 and includes a payplan increase of 2.6% each year over the FY01 fiscal year salary levels for all incumbents plus appropriate Personal Services Matching costs.

The Board has made change level requests for Capital Outlay totaling \$2,500 for FY02 and \$2,000 for FY03 to update computers and equipment.

The Executive Recommendation provides for the Agency Request.
