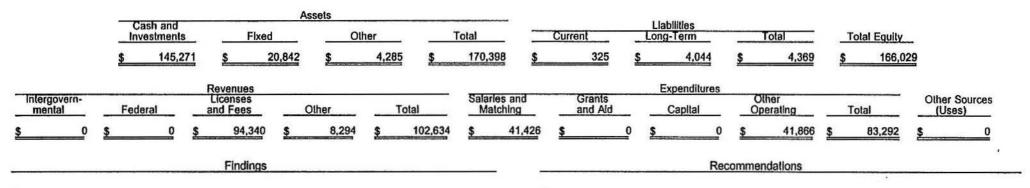

## ARKANSAS BUDGET SYSTEM ANALYSIS OF BUDGET REQUEST 2001 - 2003

The Arkansas State Board of Chiropractic Examiners was created by Act 126 of 1915. The Board is a cash agency funded from examination and license renewal fees charged pursuant to subchapter 3 of Arkansas Code Annotated §17-81. This Board was created to safeguard the public health and welfare of the citizens of Arkansas by providing for the licensure and examination of any person practicing or offering to practice chiropractic in the State. The FY01 budgeted amount of \$110,421 consists of Regular Salaries and Personal Services Matching for one regular position (Executive Director), one Extra Help position, Operating Expenses, Conference Fees & Travel and Professional Fees & Services. The Agency requests Base Level of \$105,075 for FY02 and \$106,329 for FY03 that includes a payplan increase of 2.6% each year over the FY01 fiscal year salary levels for all incumbents plus appropriate Personal Services Matching costs.

Change Level requests of the Board total \$7,800 for both FY02 and FY03 and include Extra Help Salaries of \$6,000 each year to allow the Board to maintain its current level of efficiency in facilitating the license renewal process as well as other daily operations of the Board and Personal Services Matching of \$1,800 each year to cover the increase request in Extra Help salaries.

The Executive Recommendation provides for the Agency Request.
