1997-99 BIENNIAL BUDGET

Our board operates solely on revenues collected. In May of 1996 we increased our fees which will increase our income (receipts) by approximately \$20,000 each year which will more than cover the following priority requests:

- (1) An additional request of \$7000 for Character 01 is being requested to increase the salary for our Secretary-Treasurer from \$2000 to \$4000 per year as his/her duties are becoming more extensive due to the volume of complaints received each year.
- (a) We are requesting an additional position in extra help to hire a second investigator (\$5000 of the above \$7000 requested will cover his salary and that of the investigator we currently have on staff).
- (b) An additional request of \$3000 for Character 10 is being requested to hire a second investigator under "Contract Labor" if our request for an additional extra help position is not granted.
- (2) An additional request of \$600 for Character 46 is being requested to cover the increased cost in office rent and travel expenses for board members.
- (3) An additional request of \$3600 for Character 02 is being requested due to the rising cost of office supplies, printing, postage and telephone charges. Also, a request is being made to cover the cost of replacing worn carpet in our office (installed in June of 1978).

ARKANSAS BUDGET SYSTEM ANALYSIS OF BUDGET REQUEST 1997 - 1999

The Veterinary Medical Examining Board is a special revenue funded agency which derives its funding from the licensing and examining of veterinarians. The budget request for the Veterinary Medical Examining Board reflects a Base Level of \$63,824 in FY98 and \$64,886 in FY99, covering one position. Priorities were requested in the areas of Operating Expenses, Extra Help, and Professional Fees and Services. Operating Expenses will cover cost increases in postage, telephone, travel reimbursement, and other office related expenses, as well as rental increases as dictated by State Building Services. Due to the increase in veterinary related complaints, the Board in requesting an increase in Extra Help appropriation as well as one additional position to hire a second investigator. This appropriation will provide additional hours and personnel on an as needed basis to investigate their complaints. Professional Fees and Services will provide cost increases to hire an additional investigator under contract labor.

Expenditure of this appropriation is contingent upon the availability of adequate funding.

The Executive Recommendation provides for Base Level, which includes appropriation for a 2.8% Cost of Living Allowance for the position on July 1 of each year of the biennium, as well as the Agency's priority request for Operating Expenses, one Extra Help position and appropriation, and Rent Expense.
