### ARKANSAS BUDGET SYSTEM AGENCY PROGRAM COMMENTARY 2001 - 2003

The Information Age is increasing the demand for quality data analysis in every area especially criminal justice whose agencies have grown significantly in the past decade. The Sentencing Commission is in a unique position to offer quality data analysis of criminal justice laws, policies and practices from a neutral viewpoint. Whereas the major correctional agencies have massive budgets and internal information services to serve their own needs, the Sentencing Commission, representing the courtroom practitioners can review the data obtained from the Department of Correction, the Department of Community Punishment and the Administrative Office of the Courts from a neutral "criminal justice systems" viewpoint, i.e., the overall picture from the courtroom to the state agency. It is charged with presenting this information to the Governor, the legislature, the Judicial council and the public. With better technology and procedures, this data can be closely monitored for changes and immediate impact on the State resources.

The Commission has also staffed the Coordinating Council for Integration of Justice Information Systems during this biennium. Integration of justice information systems is a nationwide effort to improve public safety and the system by having timely, accurate and complete records on offenders. Justice information starts with the courtroom practitioners and local agencies. This information then could be electronically transmitted to the state agencies who also will need to share their information with each other and the local agencies. It is anticipated that this effort will continue and be phased in over a period of time. The Commission will play a critical role in this process as its focus is and always has been on the system wide flow of good information. The Department of Justice will be funding some of these efforts. It will be critical for the Commission to continue monitoring the national efforts and to maintain communications with all local practitioners.

The Commission must have a networked internal system with up to date hardware and software to handle the major data bases which are currently available and additional data bases which may become available. Our current hardware was purchased in 1993 and needs to be replaced. There are currently three major data bases involved in the system, those of the Department of Correction, Department of Community Punishment, and the Administrative Office of the Courts. In order for the Sentencing commission to make accurate prison population projections and to track the impact which current and new laws may have on the criminal justice system, it must be able to analyze the enormous amounts of data provided by these three systems. This information is vital in planning for the best use of corrections resources.


Dissemination of data to the public is one of the primary functions of this agency. An Internet web page achieves this function efficiently and at less expense. The standards are available for downloading and answers to frequently asked questions are readily available. This site needs to be monitored and updated on a regular basis. Annual reports, statistical analyses and impact studies may be added to the site in the future.

Quality data analysis depends upon quality data. In order to improve timeliness, accuracy and completeness, the Commission conducts training seminars at the local level in the various judicial districts of the State. Communications with the local districts depends upon up to date information technology. E-mail functions have greatly increased between state agencies during this biennium and will increase greatly with the local communities in the future.

It is the Commission's understanding that quality statewide communications between agencies and the availability of quality information to the public and policy makers is a goal of the Governor, the legislature and the judiciary. The Commission believes that the projects outlined above will assist it in fulfilling in its statutory duties and meeting this worthy goal.

## ARKANSAS BUDGET SYSTEM ANALYSIS OF BUDGET REQUEST 2001 - 2003

The Arkansas Sentencing Commission was established by Act 709 of 1993 for the purpose of instituting sentencing standards to ensure that sanctions imposed following conviction are proportional to the seriousness of the offense of conviction and the extent of the offender's criminal history. The Commission has developed the sentencing grid, the seriousness reference table and established transfer eligibility for all offenses. The Commission provides impact assessments on proposed legislation for the Governor and General Assembly through a professional service contract with the National Council on Crime and Delinquency (NCCD). This contract also has provided training to the staff of the Sentencing Commission and the Department of Correction in the use of a software program that is utilized in data analysis of criminal justice laws, policies and procedures.

This is the primary operating appropriation of the Commission. It is funded entirely by General Revenue.

The Agency Request is for Base Level which includes a pay plan increase of 2.6 % each year over the 2001 fiscal year salary levels for all incumbents plus appropriate Personal Services Matching costs.

The Agency Request of \$ 9,262 in FY02 and \$ 8,260 in FY03 includes a request for the following: Operating Expense of \$762 in FY02 and \$ 760 in FY03 for the repair of office equipment Conference Fees & Travel of \$ 1,000 each year respectively to attend training seminars Prof Fees and Services \$ 1,500 in FY 02 and FY03 for costs associated with the National Council On Crime and Delinquency Capital Outlay request of \$ 6,000 in FY02 and \$ 5,000 in FY03 for the integration of information associated with peer to peer network complex and associated hardware upgrades.

The Executive Recommendation provides for Base Level and appropriation for the Agency Request of Capital Outlay of \$ 6,000 in FY02 and \$ 5,000 in FY03 and recommends the reallocation of resources as requested by the Agency for the remainder the Agency Change Level request.
