Appropriation 227. Salaries

The agency is not requesting any '03 –'05 biennium increases beyond the base level of the FY03 budget, except for those recommended to the agency for inclusion by DF&A in Regular Salaries and Personal Services Matching, i.e., those normally included automatically in budgets and the proposed 2.7% Cost of Living Increase for each year of the biennium for all employees. Since the agency was not approved to participate in the CLIP Program (i.e., approved and funded for additional positions in order to create a career ladder for classified employees), the only way to acknowledge those staff members that exceed standards is to allow them to be eligible for a merit bonus based on annual agency established CLIP II evaluation process. Should each of the four classified staff exceed standards and the evaluator decides that each individual should receive the maximum 8% bonus, the agency requests that \$8,602.00 (based on 2.25% of total salary appropriation) be made available, in each year of the biennium, either as part of the biennial appropriation or with the understanding that the agency will be applying to the Merit Adjustment Fund for any bonus monies for exceptional performance by Claims Commission classified staff members.

Appropriation 227. Conference Fees & Travel

The agency requests no increase and requests that the current base amount of \$3,000.00 (established in 1993 and continued through the 2001-2003 biennium) be continued in both years of the '03 –'05 biennium. In order that agency employees continue to enhance their skills and have the opportunity to attain specialized certifications which augments our capacity to better accomplish our agency's mission, a continued appropriation is needed to cover expenses of attending meetings of professional and educational organizations and obtaining additional educational training to improve employee job performance.

Appropriation 227. Maintenance and General Operation

The agency is requesting to increase the FY'03 base of \$80,500.00 by \$2,500.00 (based on an inflation factor slightly over 3.1%) to \$83,000.00 in FY'04 to cover likely increased costs in postage, paper, copying, document imaging, archiving historical claims data, and an expected cost of having to purchase services from DIS to insure that the new (as of July 2001) Claims Tracking Database System operates efficiently. While continuing these Year 1 work items, the Commission in Year 2 (FY'05) of the biennium is requesting an additional \$5,000.00 (based on an inflation factor of slightly under 3.1%) to \$85,500.00 to, in addition to the above mentioned items,

initiate development of an agency page on the Internet so that public may be more quickly informed and served by the agency, which will necessitate the purchase of appropriate computer software. All updating of computer, printer and other hardware and software purchases will come from this funding area during the '03-'05 biennium. Also, as the agency's copier will be over ten years old in Year 2 of the biennium, costs associated with the procurement of a new copier system can be expected.

Appropriation 228. Death, Disability and Other Claims

The agency <u>requests no increase</u> from the \$1.3 million annual base of the current(and two previous)biennium's for each year of the 2003-2005 biennium.

ARKANSAS PERFORMANCE BUDGETING & ACCOUNTABILITY SYSTEM ANALYSIS OF BUDGET REQUEST 2003 - 2005

This appropriation provides for the personal services and operating expenses of the State Claims Commission. The Commission is a quasi-judicial body established to hear claims against the State of Arkansas and its agencies, boards, commissions, and institutions, unless otherwise exempted by statute. The Commission consists of a staff of 10 positions, including 5 commissioners appointed by the Governor.

The Base Level request includes a 2.7% salary increase each year over the FY03 salary levels for all incumbents plus associated Personal Services Matching. Included in Personal Services Matching is a \$33 per month increase in the monthly contribution for State employee's health insurance for a total state contribution of \$280 per month per budgeted employee.

Change Level requests total \$2,500 in FY04 and \$5,000 in FY05 for Operating Expenses to cover anticipated increases in postage, paper, copying, document imaging, archiving historical claims data, and an expected cost of having to purchase services from DIS to insure that the new Claims Tracking Database System operates efficiently.
