

## **History and Organization**

The mission of the Alcoholic Beverage Control Enforcement Division is to enforce all Arkansas Code Annotated Laws of the State Control Act, cigarette, sales, Rules and Regulations adopted by the Alcoholic Beverage Control Board, and the training and assistance for all law enforcement agencies as well as other organizations regarding alcoholic beverages.

Alcoholic Beverage Control Enforcement Division was established with the creation of the Alcoholic Beverage Control Department of 1935. The head of the Alcoholic Beverage Control Enforcement Division is appointed by the Director of the Department of Finance and Administration with the approval of the Governor.

In addition to enforcement, the Alcoholic Beverage Control Enforcement Division conducts background investigations of those persons, businesses and organizations who apply for licenses under the Alcoholic Beverage Control Act. The Alcoholic Beverage Control agents conduct inspections and report on permit applications in addition to the investigations of violations and apprehensions of violators. The agents also investigate and inspect the damaged shipments of any controlled beverages which have been involved in a fire, wreck, or other casualty to certify the extent and the amount of damage for the purpose of returning any taxes which have been paid to the State. The agents also answer complaints, confiscate moonshine and perform other special assignments; such as food stamp fraud when used to purchase alcoholic beverages. All Alcoholic Beverage Control Enforcement agents must be certified law enforcement officers.



#### **Agency Commentary**

The Alcoholic Beverage Control Enforcement Division is responsible for enforcement of alcoholic beverage control laws and regulations within the State. ABC Enforcement agents are certified law enforcement officers.

The ABC Enforcement Division is funded from general revenue. An increase over Base Level in the amount of \$90,547 for FY08 and \$58,047 for FY09 is being requested. Included in this amount is \$39,547 each year for salaries and matching to restore a currently authorized grade 20 ABC Senior Enforcement Agent position; \$5,000 each year for Capital Outlay to pay sales tax for the replacement of three vehicles; and additional Maintenance & Operation of \$46,000 for FY08 and \$13,500 for FY09. Included in the \$46,000 request for FY08 is a one time expense of \$32,500 for the purchase of weapons, body armor and emergency lighting. This equipment is needed for the agents due to being in high risk situations, working more frequently with local law enforcement and needing to replace extremely outdated weapons. The remaining \$13,500 would cover increased costs for vehicle maintenance, fuel purchases, tires and telecom wireless charges.

### **Analysis of Budget Request**

**Appropriation:** 1SQ - ABC Enforcement - Federal

**Funding Sources:** FFC - ABC Enforcement Federal

This federally funded appropriation will provide operations for the Department of Finance and Administration - Alcoholic Beverage Control (ABC) Enforcement Division, Combating Underage Drinking Program. The Program helps to reduce the availability of alcoholic beverages to minors and the consumption of alcoholic beverages by minors. Activities of the program include targeting establishments suspected of a pattern of violations of State laws governing the sale and consumption of alcohol by minors, public advertising programs to educate establishments about prohibitions and sanctions, and innovative programs to prevent and combat underage drinking.

The FY07 budgeted amount of \$484,174 consists of Overtime and Personal Services Matching for after hours and weekend compliance checks; Operating Expenses for law enforcement activity with regard to the sale of alcohol to minors; Conference and Travel Expenses for National Association of Alcohol Enforcement Officers meetings; and Grants and Aid to various organizations.

The Base Level for this appropriation is \$484,754 each year of the biennium. Personal Services Matching reflects an increase in Worker's Compensation and Unemployment Tax rates. Base Level represents the Agency Request.

The Executive Recommendation provides for the Agency Request.

#### **Analysis of Budget Request**

**Appropriation:** 217 - ABC Enforcement - State

**Funding Sources:** HUA - Miscellaneous Agencies Fund

This general revenue funded appropriation provides for operations of the Department of Finance and Administration - Alcoholic Beverage Control (ABC) Enforcement Division. This division is responsible for enforcement of alcoholic beverage control laws and regulations within the State. ABC Enforcement agents are certified law enforcement officers.

The FY07 budgeted amount of \$1,027,933 consists of Regular Salaries and Personal Services Matching for 19 positions, Operating Expenses and Capital Outlay.

A cost of living increase is not incorporated in Base Level pending the outcome of the Classification and Compensation Study. FY07 salary levels have been held flat each year for all incumbents. Personal Services Matching may reflect increases in the Base Level due to the Social Security Tax maximum income limit and certain increases in Worker's Compensation and Unemployment Tax rates. Personal Services Matching also includes a \$30 increase in the monthly contribution for State employee's health insurance for a total State match per budgeted employee of \$350 per month.

A.C.A. §3-2-210(b) states that all duly designated enforcement agents shall have the powers, rights, and protection provided to all other law enforcement officers by the laws of this state, specifically including the power of arrest and service of warrants and the right to bear arms in the line of duty.

Currently issued weapons are outdated and cause difficulty in successfully completing firearms training. Current weapons are six shot revolvers and not easily concealed. Most agencies issue a compact model to their plain clothes officers, because the weapon is easily concealed. All law enforcement agencies issue their officers not just a weapon but some type of body armor as well. ABC Enforcement agents are issued a weapon and are expected to place themselves at risk, so the proper protection should be provided. Emergency lighting and equipment is also used for the agent's safety. This equipment enables the agents to render aid to both the public and other law enforcement officers.

The Base Level request for this appropriation is \$1,035,897 for both years of the biennium. The ABC Enforcement Division is in need of additional appropriation and general revenue funding for the 2007-2009 biennium for the following:

- Restoration of one currently authorized position, Senior Enforcement Officer, Grade 20, due to increasing compliance checks and related workload. Agents are being more proactive, covering more of their assigned areas and working with local law enforcement much more frequently.
- Operating Expenses in the amount of \$46,000 for FY08 and \$13,500 for FY09 for new weapons, body armor, and emergency lighting equipment (\$32,500 for FY08); wireless charges and the increases in maintenance, tires and fuel for vehicles (\$13,500 each year)

• Capital Outlay in the amount of \$5,000 for each year would pay for sales and use tax on the replacement of three (3) new vehicles each year

The Executive Recommendation provides for the Agency Request for additional appropriation and general revenue funding over Base Level for the following:

- Restoration of one currently authorized position, Senior Enforcement Officer, Grade 20 (\$29,394 each year for Regular Salaries and \$10,153 each year for Personal Services Matching)
- Operating Expenses in the amount of \$28,500 for FY08 and \$13,500 for FY09 (\$15,000 for FY08 for new weapons, body armor, and emergency lighting equipment and \$13,500 each year for wireless charges and the increases in maintenance, tires and fuel for vehicles)
- Capital Outlay of \$5,000 for each year for sales and use tax
