The mission of the State Crime Laboratory is to serve the criminal justice system by providing forensic science services on evidentiary material submitted by law enforcement agencies and to provide expert testimony at time of trial. The analysis is to be made in an accurate and timely manner as to insure defendant's right to a speedy trial is not hampered and the administration of justice is not overly delayed. These services are to be provided at no charge to the submitting agency.

The budget requested for the 2003-2005 budget basically contains the same type of request that has been requested in past years. The increase in personnel is to bring the laboratory back to the 2001-2003 level with the necessary funding to accomplish this. It reflects the need for funding of three drug chemist in the second year of the biennium. These three chemists have been paid through federal COPS funding by direct grant to the State Crime Laboratory. An additional position has been requested for our Information Technology section to stay abreast of the changes in this area. Request to restore funding for conference fees and travel which was deferred during FY 2003 because of general revenue allocation and the budget reduction. Continuing education plays a vital role in keeping laboratory personnel up to date in methodology and for keeping their "expert" status. A major program change in the operations of the laboratory is seeking national and international accreditation through the American Society of Crime Laboratory Directors' Laboratory certification process. Funding for this certification has been requested as well as a position of Quality Control/Quality Assurance Manager and a secretarial position to insure that accreditation is maintained after certification. The only new program that has been requested is to establish a forensic computer analysis section. It seems that at almost every crime scene today, there is a computer present. The laboratory has been approached by the law enforcement community on several occasions requesting assistance in handling these cases. The FBI, who has played a major role in this area has indicated that they are reducing services to local law enforcement in this area. As always, it seems maintenance and operation to operate the agency has never been enough. During the last fiscal year, to offset the general revenue reduction effect, the laboratory used funding from the confiscated fund account. We negotiated with State Building Services on the paying our paying for some needed deferred maintenance items during remodeling in lieu of rent payment. This action and the way the system has captured the expenses in appropriation 1VM has caused the continuing level budget to not reflect the true expense of rent, thus causing an inflated increase in continuing level operation. This is further inflated by notification that the rent for the laboratory will increase to \$813,832 per year during the 2003-05 biennium. The contract for carrier gas used for most of the scientific equipment has indicated that their rates will increase by 51% and the cost of telecommunications for the laboratory is anticipated to increase significantly in the second year of the biennium.

Caseload continues to increase yearly. The amount of evidence collected and submitted increases as the education level of law enforcement grows. Addressing this, authorization and funding for a regional crime laboratory to handle drug cases was appropriated for Hope. The budget request reflects the continuation of this program. DNA, an outstanding technique for criminal investigation has become a "gold standard" requested not only by law enforcement, but also prosecutors and public defenders. However, this is an expensive process and must be looked at as we progress toward requiring DNA samples from all convicted felons. The medical examiner section continues to see over 1,000 cases per year with four pathologists. As legislation mandates more authorization to request post mortem examination of cases, an additional forensic pathologist is required to meet the demand.

This federally funded appropriation provides six (6) Forensic Chemist positions that are utilized by the State Crime Lab in the investigation and dismantling of illicit methamphetamine labs. Due to the highly toxic nature of the chemicals used in the manufacture of methamphetamine, extreme care must be taken in collecting the chemicals at the lab sites and strict Environmental Protection Agency guidelines must be following in dismantling and disposing of the chemicals. Three (3) of these positions were authorized by the 83rd General Assembly after being initially approved through the Miscellaneous Federal Grant process. The second group of three (3) positions was authorized during the 2002 Fiscal Year, again through the Miscellaneous Federal Grant process.

The Base Level request of \$180,450 for Fiscal Year 2004 and \$184,757 for Fiscal Year 2005 includes a 2.7% salary increase each year over the Fiscal Year 2003 salary levels for all incumbents plus associated increases in Personal Services Matching. Included in Personal Services Matching is a \$33 per month increase in the monthly contribution for State employee's health insurance for a total state contribution of \$280 per month per budgeted employee.

The State Crime Lab is requesting \$125,429 in Salaries and Matching for Fiscal Year 2004; and \$128,543 in Salaries and Matching for Fiscal Year 2005 to continue the three (3) positions created in Fiscal Year 2002.

The Arkansas State Crime Laboratory was created by Act 517 of 1977, to provide forensic and scientific support to the criminal justice system in Arkansas. The Executive Director of the State Crime Lab is appointed by the Governor. Act 383 of 1991, created the State Crime Laboratory Board, made up of eight (8) members, including the Dean of the UAMS College of Medicine and seven (7) members appointed by the Governor with confirmation of the Senate. The Board members' terms are for seven (7) years. The Board has the authority to employ and remove the State Medical Examiner.

The Arkansas State Crime Laboratory provides complete forensic laboratory services and corroborative testimony for the state's law enforcement and criminal justice community to assist in the apprehension and conviction of individuals involved in criminal activities. These services are provided at no cost to the law enforcement and criminal justice community. During the past year, the State Crime Lab participated in over 24,000 cases, processing over 39,000 items of evidence. Included in the total number of cases were 1,105 autopsies completed.

Appropriation 498 is the primary operating account for the Arkansas State Crime Laboratory. It includes 111 authorized fulltime positions and is funded by General Revenue through the State General Services Fund (HUA) and a transfer of funding from the Administration of Justice Fund as authorized by Section 27 of Act 1666 of 2001.

The Base Level request of \$6,035,222 for Fiscal Year 2004 and \$6,169,601 for Fiscal Year 2005 includes a 2.7% salary increase each year over the Fiscal Year 2003 salary levels for all incumbents plus associated increases in Personal Services Matching. Included in Personal Services Matching is a \$33 per month increase in the monthly contribution for State employee's health insurance for a total state contribution of \$280 per month per budgeted employee.

For the 2003-2005 Biennium, the Arkansas State Crime Laboratory is requesting change levels of \$1,583,382 for Fiscal Year 2004 and \$1,584,570 for Fiscal Year 2005.

The Base Level request of \$152,238 for Fiscal Year 2004 and \$153,905 for Fiscal Year 2005 includes a 2.7% salary increase each year over the Fiscal Year 2003 salary levels for all incumbents plus associated increases in Personal Services Matching. Included in Personal Services Matching is a \$33 per month increase in the monthly contribution for State employee's health insurance for a total state contribution of \$280 per month per budgeted employee.

The State Crime Lab is requesting \$70,612 in Salaries and Matching for Fiscal Year 2004; and \$72,337 in Salaries and Matching for Fiscal Year 2005 for the continuation of two (2) positions not budgeted in the current Fiscal Year and for the upgrade of the Evidence Technician position from Grade 16 to Grade 18. Funding for the 2003-2005 Biennium would be provided by carry forward of the existing fund balance and a transfer of \$107,049 from the Special State Asset Forfeiture Fund. This fund transfer provision is included in the agency's request for Special Language.

The Executive Recommendation provides for continuation of the two (2) positions, but does not include the personnel upgrade. With the elimination of the upgrade, the Executive Recommendation, reflected in the funding summary and the Special Language, would authorize the transfer \$103,964 from the Special State Asset Forfeiture Fund.

For the 2003-2005 Biennium, the Arkansas State Crime Laboratory is requesting change levels of \$40,367 for Fiscal Year 2004 and \$41,366 for Fiscal Year 2005 in Salaries and Matching to restore one (1) Forensic Chemist position not budgeted in Fiscal Year 2003 due to funding limitations.

Funding for this appropriation is Special Revenue generated by a mandatory fine of not less than \$250 for persons required to submit a DNA sample under the provisions of this legislation. The sentencing court has the discretion to waive the fine, if in its opinion; the imposition of the fine would cause undue hardship.

The Base Level request of \$85,019 for Fiscal Year 2004 and \$86,018 for Fiscal Year 2005 includes a 2.7% salary increase each year over the Fiscal Year 2003 salary levels for all incumbents plus associated increases in Personal Services Matching. Included in Personal Services Matching is a \$33 per month increase in the monthly contribution for State employee's health insurance for a total state contribution of \$280 per month per budgeted employee.

For the 2003-2005 Biennium, the Arkansas State Crime Laboratory is requesting change levels of \$25,600 for each year in Operating Expenses for additional lab supplies and reagents due to the anticipated increase in DNA testing with the addition of persons convicted of the offenses of residential and commercial burglary and the implementation of mitochondrial DNA analysis. In addition, the State Crime Lab is requesting \$8,500 in each year of the Biennium in Conference Fees and Travel to provide continuing education for Forensic Biologists working in the DNA field.

The Executive Recommendation provides for the Agency request.
