The State of Arkansas, Department of Finance and Administration - Intergovernmental Services (IGS) announces the availability of Local Law Enforcement Block Grant funding under the U.S. Department of Justice's Office of Justice Programs' (OJP) Bureau of Justice Assistance (BJA) Justice Assistance Program (JAG). Program participants should **carefully** review the assurances and special conditions of the proposed award funding as well as the application documents and final reporting requirements. Applications will be received in three rounds. Eligible applicants for each round are posted as a link on the website as well as an overall eligible applicant list.

**ELIGIBILITY ENTITY**

Program participants are limited to only the eligible cities and counties determined by the federal government. (See posted list for eligibility) The applying entity **must** be the authorized elected official, mayor or county judge. Applying entity **must** have an active UEI and agree to Direct Deposit. Eligible applicants can submit applications according to the posted LLEBG instructions. Eligible applicants for each round are posted as a link on the website as well as an overall eligible applicant list for SFY23.

**SUBMISSION AND DEADLINES**

Request for Application (RFA) and supporting documentation are due by 4:30 p.m. Central Standard Time on **the deadline date denoted in the instructions**. (US Mail or Carrier/Hand Delivery. No emailed or faxed Applications will be accepted)
