

**ARKANSAS BUDGET SYSTEM
AGENCY PROGRAM COMMENTARY
1997 - 1999**

The following budget requests, information, and explanation of priorities affect Appropriation A18 which authorizes expenditures from this Commission's General Fund, and Appropriation B48 which authorizes expenditures from this Commission's Recovery Fund. The base level budget is satisfactory for anticipated FY98 & FY99 expenditure needs except for priorities listed below. Funding for the FY98 & FY99 budget will be provided from funds on hand and from fees to be collected.

Priority requests for Appropriation A18

- PO1: The request is for purchase of office equipment, machines, and furniture that need replacement, and purchase of computer equipment for networking in AREC office and for electronic imaging. The computer equipment will be used for increased efficiency in administrative, licensing and accounting functions, for archiving license records, investigative files, administrative files and accounting records, for desktop publishing AREC newsletter, for AREC staff use by Administrative, Investigative and Licensing Departments, and to make information more accessible to the public.
- PO2: Increased amounts requested for payment of official Hearing Officer employed under Professional Services Contract.
- PO3: Increased amount requested for routine building maintenance and repairs.
- PO4: Increased amount requested to allow for investment of funds.

Priority Requests for Appropriation B48

- PO1: Increased amounts requested for publication of AREC newsletters and other educational materials sent to real estate licensees.
- PO2: Increased amount requested to allow for investment of funds.

**ARKANSAS BUDGET SYSTEM
ANALYSIS OF BUDGET REQUEST
1997 - 1999**

The Arkansas Real Estate Commission is funded from the receipt of fees it charges for real estate licenses. The Commission is not requesting any fee increases for the 1997-99 Biennium. Base Levels for the Commission's operating appropriation are \$1,209,845 for FY98 and \$1,229,974 for FY99, with 20 positions authorized. Priorities included in the Agency Request for the main operating appropriation (A18) are as follows:

Increases of \$5,000 each year in Operating Expenses for building maintenance and repairs.

Additions in Professional Fees & Services of \$2,000 each year for hearing officer expenses.

Capital Outlay of \$57,500 in the first year and \$25,000 in the second year for replacement of office equipment and purchase of data processing equipment for office networking and electronic imaging.

Increases of \$59,544 each year for investment of excess license fees.

Base Level for the Real Estate Recovery Fund appropriation (B48) is \$444,481 each year. Additions requested for the Recovery account are as follows:

Increases of \$23,394 each year for investment of additional funds held in the Recovery account.

Additions of \$7,500 each year in the Education line item for publication of newsletters and other educational material sent to real estate licensees.

The Executive Recommendation for the main operating appropriation (A18) is for the additions requested for investment and Capital Outlay of \$57,000 for FY98 and \$7,500 for FY99.

The Executive Recommendation for the Real Estate Recovery Fund (B48) is Agency Request.
