* Tax treatment did not differ between conventional wells and high cost wells from 1/1/2003 through 12/31/2008, hence no data was captured on the separate types of wells. Starting 1/1/09, Act 145 created Conventional and High Cost Wells with separate and distinct taxation.

MCF amounts are derived from the monthly tax reports filed with the Department. Taxpayers file monthly MCF adjustments, which change the MCF reflected above. To mitigate the out-of-date information and constant change of statistical information, MCF statistics will be undated quarterly. Quarterly updates will be made after the 25th day of the second month following production. (ie. Dec 2010 return will be filed by Feb. 25, 2011 and 2010 4th quarter statistical information will be available the first week in Mar. 2011.
