## MINUTES OF THE ALCOHOLIC BEVERAGE CONTROL BOARD

failed to enter correct UIN's on cannabis sales to patients (27 counts); facility failed to record medical cannabis sale to patients:

- ABC staff attorney, Chip Leibovich presented an evidence packet, and Chairman
   Blass accepted it for review by the Board members.
- The licensee's attorney, Erika Gee was given room to explain why the applicant was present on this day.
- ABC Agent, Robert Bacile testified about the investigation and explained what the ABC Enforcement Division considers a "mis-grab."
  - Erika Gee questioned Agent Bacile.
  - Board member Jamie Anderson questioned Agent Bacile.
- Haley Allen, ABC, testified about mis-grabs.
  - Erika Gee questioned Mrs. Allen.
- Attorney Gee asked Pursprit Cannabis Co employee, Mr. Smith to testify, where she questioned him.
  - Attorney Gee presented evidence charts to the board members, and
     Chairman Blass accepted it for by the board members.
  - Mr. Smith explained what the chart contained.
    - Board member Steven Smith questioned Mr. Smith about the contents of the chart, where Mr. Smith responded.
    - Attorney Gee also followed up on Board member Steven Smith's question.
  - Attorney Gee moved on to new questions for Mr. Smith.

- Attorney Gee asked Pursprit Cannabis Co employee, Mr. Gay to testify, where she questioned him.
- Attorney Gee asked the licensee, Mrs. Parker to testify, where she questioned her.

- Chairman Blass asked for closing statements, where attorney Gee stated hers,
   and ABC staff attorney, Chip Leibovich followed up with his.
  - Chairman Blass questioned ABC staff attorney, Chip Leibovich, where he responded.
- Board member Steven Smith provided closing statement for the ABC Board, where he
  motioned to uphold the director's decision, and Board member Pamela DePreist
  seconded, and the motion passed with a 5-0 vote.

Following this, crowd member (name unknown) asked to speak on behalf of the industry, where Chairman Blass allowed him to speak, and so asked for consideration from the Board to allow for leniency on adjustment rules.
