### INSTRUCTIONS FOR OBTAINING THE SPECIAL LICENSE PLATE

RESTRICTIONS – Issuance is restricted to passenger cars, all  $\frac{1}{2}$  ton and  $\frac{3}{4}$  ton trucks, and 1 ton trucks use for private transportation only. One (1) ton trucks used for commercial purposes must be registered with a commercial license.

In addition to normal annual registration fees, there is an additional fee in the amount of ten dollars (\$10.00) for the Veterans of Foreign Wars. These fees are due annually.

See the front of this form for the Revenue Offices where these plates are available. If a special plate is lost, it may be replaced with another special plate only in the offices listed. The special plates may be renewed by Internet, phone, by mail, or in any Revenue Office. They may be transferred to a newly acquired vehicle in any Revenue Office.

# OBTAINING A SPECIAL LICENSE PLATE FOR A VEHICLE ALREADY TITLED AND REGISTERED TO THE APPLICANT

REQUIREMENTS – Two options are available when obtaining a special plate when the vehicle is already titled and registered in the applicant's name.

Option 1 – If the applicant's existing plate is current, it may be replaced with a special plate. With this option, the special plate will keep the same expiration date as the plate being replaced. Applicants will get the entire benefit of the full registration fee paid for the plate being replaced. However, since the expiration date will remain the same, they will not get a full year's benefit of the \$10.00 special fee. When renewing, the applicant will be required to pay the additional fee again.

Fees for obtaining the plate using option 1 are as follows:

Special design use fee for the special plate is.\$ 10.00Fee for replacement of the regular plate.\$1.00Postage fee (if the transaction is done by mail)\$5.00, or if in person \$.50 cents.Total Fees (if the transaction is done by mail)\$16.00 or if in person \$ 11.50

#### Other requirements are:

- Completed Veterans of Foreign Wars Special License Plate form.
- For initial issuance copy of membership card for Veterans of Foreign Wars
- Veterans should provide their DD214, or other document evidencing their service in a theatre of operations of a war/conflict.

**Option 2** – The applicant may request to pay the normal full year registration fee for the vehicle and begin the special license plate with a full year's registration. With this option, the applicant will get full benefit of the \$10.00 additional fee. However, no credit will be given for the time remaining on the plate being replaced.

Fees for obtaining the plate using option 2 are as follows:

The full year registration fee normally due for the vehicle will be due. For Veterans the registration fee for the first license plate is \$1.00. For one additional plate and Auxiliary members for passenger cars, this fee will either be \$17.00, \$25.00, or \$30.00 depending on the vehicle's unladen weight. For qualifying trucks (see restrictions) the full year fee is \$21.00.

Special design use fee is \$10.00

Validation decal fee is \$2.50.

Postage fee if the transaction is done by mail is \$5.00.

Postage fee if the transaction is done in person in the Special License Unit is .50 cents.

Total fees depend on the normal registration fee for the vehicle and postage fees.

# Other requirements are:

- Completed Request for Veterans of Foreign Wars Special License Plate form.
- Proof of current liability insurance.
- If the applicant's existing license plate is expired, or will expire in the **current calendar year**, the following personal property tax information is required.
  - o Proof of personal property assessment for the current year
  - o Proof of personal property tax payment of taxes due by October 10 of the previous year.

If the applicant's existing license plate will expire the **next calendar year**, proof of personal property assessment and tax payment are not required.

# OBTAINING A SPECIAL PLATE FOR A NEWLY PURCHASED VEHICLE

If obtaining a special plate is for a newly purchased vehicle, all normal documentation for title and registration is required. Applicants should contact their local Revenue Office for assistance.
